4. Motion for Approval of September 19, 2017 Special Election Canvass, Pursuant to Section 1-13-13A NMSA 1978

COMMISSIONER MORENO: So moved. COMMISSIONER HAMILTON: Second.

The motion passed by unanimous 3-0 voice vote.

CLERK SALAZAR: Chair Hansen, you have made a motion to reconvene, a motion for approval, so you have approved the results even after the fact that you have already approved. So I'm fine with that.

COMMISSIONER HANSEN: I apologize for that.

CLERK SALAZAR: That's okay.

Commissioner Hansen: I would like to know the percentage and what was the vote of the turnout.

CLERK SALAZAR: On election night we had unofficial results of a total of 7,945 voters. The amount of voters for the GRT Special Election question was 2,388 and those against were 5,557. So those were all of the votes for that evening. After our canvassing process we had two extra votes and those were absentee votes that were mailed in. Is that correct staff? Yes. So voters have a certain time for their ballots to get into the system and those two made it in and we counted those. So as of today and your approval, we have a total 7,947 votes that were cast and the results for were 2,390 and those against, 5,557.

COMMISSIONER HANSEN: Okay, and do we have any other breakouts that are available?

CLERK SALAZAR: Let me check. Do we have a breakout per district? BUREAU ELECTION CHIEF FRESQUEZ: No, we're running them right

CLERK SALAZAR: They're being run right now and so we can get them to you maybe just before the next meeting if you'd like to see them.

COMMISSIONER HANSEN: I'd also like to see a breakout of City versus unincorporated areas.

CLERK SALAZAR: I don't think we can do that.

MR. FRESQUEZ: We can try.

Commissioner Hansen: How about by district?

CLERK SALAZAR: By district, that is what they're attempting to do right

COMMISSIONER HANSEN: Okay, so we'll have that. Thank you. Any other questions from Board members.
