III. Approval of Agenda

Chair Rodriguez requested the inclusion of a discussion regarding the March $10^{\rm th}$ meeting.

Upon motion by Ms. Johnson and second by Mr. Bing the agenda was unanimously approved as amended.

IV. Approval of Minutes: February 4, 2016 & February 18, 2016

Mr. Bing moved to approve the minutes of the February 4th and February 18th meetings. Ms. Johnson seconded and the motion passed without opposition.

V. Sign Report - FINAL

The final report was distributed for signatures.

VI. Discussion of the Report Presentation

Ms. Rendon-Varela said the presentation of the report to the BCC is not noticed as an action item. A request has been forwarded to the manager to hear the presentation early within the agenda.

Ms. Salazar outlined the protocol for addressing the Commission through the Commission Chair Miguel Chavez. She said she was pleased with the final report which is good for the youth and the taxpayer.

Mr. Sedillo said the committee should anticipate questions from the Commissioners.

It was determined that Chair Rodriguez would introduce the report. He said he would welcome contributions from task force members and staff. Bullet points will be teased out of the report for presentation purposes or Chair Rodriguez can outline the number of meetings the task force has had, the method they used to develop the report, and then stand for questions.

Ms. Salazar mentioned that the diversity of this task force was very valuable in the development of the report.

Deputy Manager Flores will be present to address the Commission's questions regarding capital outlay, physical design, finances, etc. Mr. Sedillo offered to have a representative of Public Works and the staff that supported this process present.

Ms. Lovato said master plans can be very expensive. Chair Rodriguez commented that the state's economic outlook may affect the timing of this project. Mr. Sedillo said the cost to demolish the building will require Commission consideration. Mr. Bing noted that the youth will need to be housed throughout the process.

Ms. Johnson said it may be valuable to emphasize that the task force preferred the current location because of its proximity to transportation, inclusiveness of the community and other services.

Mr. Sedillo said staff will continue to communicate with the task force on the progress of the facility and advise them when the Commission is taking action, etc. He anticipated a three to five year process in developing a design, securing funding, etc.
