These studies include the Land Use Assumptions, the Capital Improvement Plan and the Nexus Study. The County currently has \$100,000 in the budget to hire a consultant to complete the studies.

Motion was made to recommend to the BCC to proceed with the Land Use Assumptions, the Capital Improvements Plan, and the Nexus Study that are necessary to determine if the BCC should amend the ordinance for assessing impact fees.
