2. <u>Miscellaneous Action Items</u>

A. Resolution No. 2025-04-HB, a Resolution Approving the Santa Fe County Housing Authority's FY2026 Civil Rights Certification

Adrianna Velasquez explained that HUD yearly requires this certification. The Authority's CUP and Admin plan have chapters relating to internal policies on non-discrimination for persons with disabilities and those with limited English proficiency. April being the Fair Housing Month, the certification must be signed and submitted to HUD by the end of the month. The FSS Coordinator has been assigned to assist new clients with some type of impediment to ensure they have equal access to the programs.
