WATER POLICY ADVISORY COMMITTEE

MEETING

April 11, 2024

Santa Fe, New Mexico

1. A. This meeting of the Santa Fe County Water Policy Advisory Committee (WPAC) was called to order at approximately 4:00 p.m. by Carl Dickens, Vice Chair, on the above-cited date in the Palace Conference Room, 100 Catron Street Santa Fe, New Mexico. The meeting was conducted as a hybrid with people attending in person and on line.

C. Approval of Agenda

There were no changes and Ms. Wolf moved to approve the agenda as published. Mr. Egelhoff seconded. The agenda was unanimously approved. [Mr. Gonzales arrived following this action and indicated that his vote was in the affirmative.]

Brett Clavijo, Planning Manager, said his work with water and wastewater issues have increased contact with the county pueblos. Currently, he is assisting with the development of a water and wastewater master plan RFP for the La Cienega area. He recently reviewed a wetland restoration over the years. He previously served as the Transporation Manager which brought him in Brett Clavijo, Planning Manager, said his work with water and wastewater issues have increased report by Ecotone.

Manager Shaffer said he was pleased to be meeting with WPAC and was present to review the new WPAC resolution and discuss the composition of the committee to ensure that the current members' representation is reflected in the resolution. Also, terms of appointment will be reviewed.

A. Presentation Concerning Santa Fe County Resolution No. 2024-038

Ms. Wolf moved to approve the March 14, 2024 minutes. Mr. Egelhoff seconded and the motion passed without opposition. [Mr. Gonzales arrived following this action and indicated his vote was in the affirmative.]

E. Request Approval of Minutes: March 14, 2024

Ms. Wolf moved to approve the November 9, 2023 minutes. Mr. Dickens seconded and the motion passed without opposition. [Mr. Gonzales arrived following this action and indicated his vote was in the affirmative.]

D. Request Approval of Minutes: November 9, 2023

Jacqueline Beam, Sustainability Manager, said she met with WPAC in the past to discuss the MS4 permit regarding stormwater and EPA reporting. Sustainability has worked with wells and data tracking and is looking at rain gardens and other ways to incentivize backyard conservation.

Michael Carr, Sustainability Specialist, said he manages the nature-based climate solutions program as well as recycling and composting projects.

Returning to the resolution, Manager Shaffer noted that in terms of guiding principles, the 2024 resolution specifically calls out:

- Results-based accountability framework
- SMART – Specific, Measurable, Achievable, Relevant, and Time-Bound – objectives
- Geographic and culturally appropriate best practices
- Includes the voices of County youth, diversity, equity and inclusion principles

In terms of specific areas of focus, the 2019 resolution referred to aquifer storage and recharge activities, exploration of a regional water authority and consideration of drought management practices. The 2024 resolution expands upon:

- Drought management and aquifer recharge
- Incentivizing large- and small-scale water collection and pollutant reduction activities, such as rain gardens and water catchment systems
- Provision of water and other resources for abnormal events
- Develop a work plan to assure adequate water quality and quantity for seven generation/100 years for the County
- Analyze and make recommendations concerning wastewater, including but not limited to, County wastewater service options for rural and non-densely populated areas of the county, such as distributed wastewater treatment facilities

Manager Shaffer said a work plan should be presented annually to the BCC at the second January meeting; however, the work plan for 2024 is expected for presentation July 26, 2024. As far as periodic reports, the resolution calls for those reports on a quarterly basis or as identified in the current work plan.

The County Manager's Office issued a press release requesting interested residents to submit letters of interest and résumés by April 19th. The Pueblo governors with land within Santa Fe County were also contacted to make recommendations. The BCC may make appointments by April 30th. Onboarding members could occur within the May/June timeframe, the work plan being developed in June and July.

Manager Shaffer thanked the members for their service to the County and the community.

Mr. Dickens expressed his appreciation of the resolution's directness and focus. He emphasized the importance of moving forward.

Manager Shaffer said new members will be selected to fill the representation called for within the resolution; however, expertise and experience is always desired. In addition to the

B. Review of Current WPAC Membership

MS. Wolf complimented the breadth of the resolution and its forward thinking on the expansion of expertise within the committee. She mentioned the City's Scorecard that would be useful for WPA to coordinate with in terms of shared goals.

Tom Egelhoff: Appointed by BDD Board and began March 2024; 7.h. Serves as the Director of Agronomy at the Club at Las Campanas. In 2016, the Club was granted a non-voting seat on the BDD Board. A resident of Eldorado, and via the Club operates a pump station and diverts San Juan-Chama water. The Club is working to be a leader in the nation for golf course water conservation

Speaking for the staff, Manager Shaffer said they look forward to working with the re-energized and expanded WPAC.

Mr. Dickens commented that, "there are moments in time when things come together and I've got this feeling that it is coming together right now." He thanked staff and asked that WPAC's gratitude forwarded to the Commissioners who put the new resolution together.

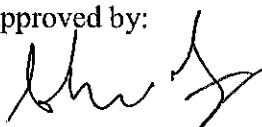
Mr. Egelhoff observed that having former County Utilities Director John Dupuis at the City has helped to develop cooperation between the two entities.

Mr. Dickens mentioned the submission of a \$1 million grant application through the BOR Water Smart Program for an aquatic eco-system restoration study and design plan. This is for the entire river and he credited Mr. Dupuis with extending the grant application to the entire river.
