3. Adjournment


Following a motion by Mr. Gowen and second by Mr. Graeser, this meeting adjourned at approximately 4:04 p.m.

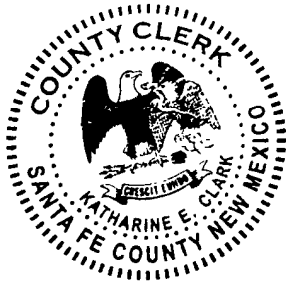
