### **SUMMARY:**

The purpose of this item is to establish a new capital fund and to transfer \$40,000 from the general fund into a new capital fund for the Santa Fe County Transfer of Development Rights Bank.

### BACKGROUND:

The Board established the Transfer of Development Rights Bank on December 13, 2016. The Resolution includes a provision for the allocation of funds for the TDR bank. The funding for the TDR bank will allow the County to purchase development rights from qualified properties for conservation.

The TDR Bank provides the County with a secure and reliable source of TDRs through the protection of areas with high conservation value. Funds from the proceeds of the sale of these development rights will be utilized to acquire additional development rights to replenish bank in order to maintain an adequate supply for development in receiving areas.

### United States Marshals Service Violent Offender Task Force – Memorandum of Understanding

### PARTIES AND AUTHORITY:

This Memorandum of Understanding (MOU) is entered into by the Santa Fe County Etentiffe Office

and the United States Marshals Service (USMS) pursuant to 28 U.S.C. § 566(e)(1)(B). As set furth in the Presidential Threat Protection Act of 2000 and directed by the Attorney General, the USMS has been granted authority to direct and coordinate permanent USMS Violent Officader Task Porces consisting of Federal, state, and local law enforcement authorities for the purpose of locating and apprehending fugitives. The authority of the USMS to investigate fugitive matters as directed by the Attorney General is set forth in 28 USC § 566. The Director's authority to direct and supervise all activities of the USMS is set forth in 28 USC § 561(g) and 28 CFR 0.111. The authority of United States Marshals and Deputy U.S. Marshals, "in executing the laws of the United States within a State . . . [to] exercise the same powers which a sheriff of the State may exercise in executing the laws thereof is set forth in 28 USC § 564. Additional suthority is derived from 18 USC § 3053 and Office of Investigative Agency Policies Resolutions 2 & 15. (See also) "Memorandum for Howard M. Shapiro, General Counsel, Federal Bureau of Investigation" concerning the "Authority to Pursus Non-Federal Fugitives", issued by the U.S. Department of Justice, Office of Legal Counsel, dated February 21, 1995. (See also) Memorandum concerning the Authority to Pursue Non-Federal Fugitives, issued by the USMS Office of General Counsel, dated May, 1, 1995. (See also) 42 U.S.C. § 16941(a)(the Attorney General shall use the resources of federal law enforcement, including the United States Marshals Service, to assist jurisdictions in locating and apprehending sex offenders who violate sex offender registration requirements).

### MISSION:

The primary mission of the task force is to investigate and arrest, as part of joint law enforcement operations, persons who have active state and federal warrants for their arrest. The intent of the joint effort is to investigate and apprehend local, state and federal fugitives, thereby improving public safety and reducing violent crime.

Each participating agency agrees to refer cases for investigation by the VOTF (Violent Offender Task Force). Cases will be adopted by the VOTF at the discretion of the District Chief Deputy. Targeted crimes will primarily include violent crimes against persons, weapons offenses, felony drug offenses, faiture to register as a sex offender, and crimes committed by subjects who have a criminal history involving violent crimes, felony drug offenses, and/or weapons offenses. Upon receipt of a written request, the VOTF may also assist non-participating law enforcement agencies in investigating, locating and arresting their fugitives. Task force personnel will be assigned federal, state, and local fugitive cases for investigation. Investigative teams will consist of personnel from different agencies whenever possible. Participating agencies retain responsibility for the cases they refer to the VOTF.

Federal fingitive cases referred to the task force for investigation by any participating agency will be entered into the National Crime Information Center (NCIC) by the USMS or originating agency, as appropriate. State or local fugitive cases will be entered into NCIC (and other applicable state or local lookout systems) as appropriate by the concerned state or local agency.

### SUPERVISION:

The VOTF will consist of law enforcement and administrative personnel from federal, state, and local law enforcement agencies. Agency personnel must be approved by the District Chief Deputy prior to assignment to the VOTF. Agency personnel may be removed at any time at the discretion of the District Chief Deputy.

Direction and coordination of the VOTF shall be the responsibility of the USMS District Chief Deputy. Administrative matters which are internal to the participating agencies remain the responsibility of the responsibility for the conduct of its personnel.

A Task Force Advisory Committee, consisting of representatives of participating agencies and USMS district personnel, may be established at the discretion of the District Chief Deputy and will meet and confer as necessary to review and address issues concerning operational matters within the VOTF.

### PERSONNEL:

In accordance with Homeland Security Presidential Directive 12, personnel assigned to the task force are required to undergo background investigations in order to be provided unescarted access to USMS offices, records, and computer systems. The USMS shall bear the costs associated with those investigations. Non-USMS law enforcement officers assigned to the task force will be deputized as Special Deputy U.S. Marshals.

Task force personnel may be required to travel outside of the jurisdiction to which they are normally assigned in furtherance of task force operations. State or local task force officers traveling on official business at the direction of the USMS shall be reimbursed directly by the USMS for their travel expenses in accordance with applicable federal laws, rules, and regulations.

If the Marshals Service receives Asset Forfeiture funding for either 1) overtime incurred by state and local investigators who provide full time support to USMS VOTF joint law enforcement teak forces; or 2) travel, training, purchase or lease of police vehicles, fuel, supplies or equipment for state and local investigators in direct support of state and local investigators, the USMS shall, pending availability of finds, reimburse your organization for expenses incurred, depending on which category of funding is provided.

Reimbursement of overtime work shall be consistent with the Fair Labor Standards Act.

Annual overtime for each state or local law enforcement officer is capped at the equivalent of 25% of a GS-1811-12, Step 1, of the general pay scale for the RUS. Reimbursement for all types of qualified expenses shall be contingent upon availability of funds and the submission of a proper request for reimbursement which shall be submitted quarterly on a fiscal year basis, and which provides the names of the investigators who incurred overtime for the VOTF during the quarter; the number of overtime hours incurred, the hourly regular and overtime rates in effect for each investigator, and the total quarterly cost.

The request for reimbursement must be submitted to the District Chief Deputy, who will review the request for reimbursement, stamp and sign indicating that services were received and that the request for reimbursement is approved for payment. Supporting documentation must accompany requests for reimbursement for equipment, supplies, training, fuel, and vehicle lesses.

### VEHICLES AND EQUIPMENT:

Notwithstanding the above, pending the availability of asset forfeiture funding and approval by the USMS in advance of any purchase, the USMS may reimburse the undersigned state or local agency for vehicles and equipment purchased in support of full time state and local investigators assigned to the VOTF involved in joint law enforcement operations. Such vehicle and equipment purchases are to be contracted for and titled in the name of the state or local law enforcement agency and must comply with requirements prescribed by the USMS pursuant to this MOU and applicable policies of the United States Department of Justice. Vehicles and equipment purchased by state and local law enforcement agencies with asset forfeiture monies provided by the USMS must remain available for exclusive use of the task force officers assigned to the VOTF by the undersigned participant agency for the duration of the task force. Upon termination of the agreement, usage and disposition of such vehicles are at the discretion of the undersigned state or local law enforcement agency.

Pending the availability of funds and equipment, the USMS will issue USMS radios, telephones, and other communication devices to each task force officer to be used for official VOTF business. All equipment used by or assigned to task force officers by the USMS or an agency will remain the property of the agency issuing the equipment and will be returned to that agency upon termination of the task force, or upon agency request.

### RECORDS AND REPORTS:

Original reports of investigation, evidence, and other investigative materials generated, seized, or collected by the VOTF shall be retained by the agency in the VOTF responsible for the case. However, evidence may be turned over to other law enforcement agencies as appropriate. Copies of investigative reports and other materials may be provided to other agencies in accordance with applicable laws, rules, and regulations. Task force statistics will be insintained in the USMS Justice Detainee Information System (JDIS) - Warrant Information Network (WIN). Statistics will be made available to any participating agency upon request.

### INDORMANTS:

Pending the availability of funds, the USMS may provide funding for the payment of informants. However, all payments of informants utilizing USMS funding shall comply with USMS policy.

### USE OF FORCE:

All members of the VOTF shall comply with their agencies' guidelines concerning the use of finearms, deadly force, and less-lethal devices. Copies of all applicable firearms, deadly force, and less-lethal policies shall be provided to the District Chief Deputy and each concerned trais force officer. In the event of a shooting involving task force personnel, the incident will be investigated by the appropriate agency(s).

### **NEWS MEDIA**

Media inquires will be referred to the District Chief Deputy. A press release may be issued and press conference held, upon agreement and through coordination with participant agencies' representatives. All press releases will exclusively make reference to the task force.

### RELEASE OF LIABILITY:

Each agency shall be responsible for the acts or omissions of its employees. Participating agencies or their employees shall not be considered as the agents of any other participating agency. Nothing herein waives or limits sovereign immunity under federal or state statutory or constitutional law.

### EFFECTIVE DATE AND TERMINATION:

This MOU is in effect once signed by a law enforcement participant agency. Participating agencies may withdraw their participation after providing 30 days advanced written notice to the District Chief Deputy U.S. Marshal.

ITEM AND ISSUE: BCC Meeting March 28, 2017; Resolution No. 2017-\_\_\_, A Resolution Authorizing the County Attorney to Bring Condemnation and Other Appropriate Court Actions to Acquire Property Interests Needed to Commence Construction of the Santa Fe River Greenway Project Within the Frenchy's Field to Siler Road Segment by July 1, 2017. (Public Works/Scott Kaseman)

### **SUMMARY**

In accordance with Santa Fe County (County) Resolution No. 2014-125, the County has now acquired through negotiation 15 of the 18 parcels needed to construct the Frenchy's to Siler Segment of the Santa Fe River Greenway Project (Project). Resolution No. 2016-129 authorized the County Attorney to pursue a condemnation action against claimants who allege an interest in one of the two remaining parcels, and the County Attorney recently initiated that action. Staff now requests the Board of County Commissioners (BCC) to authorize the County Attorney bring condemnation or other appropriate court actions to assure timely acquisition of all necessary property interests in the Frenchy's Field to Siler Road Segment.

### <u>BACKGROUND</u>

The County and the owner (Property Owner) of the two parcels shown on the attached exhibits entered into two purchase agreements. Although the Property Owner is under contract with the County to sell the parcels at an agreed-upon price, the Property Owner now refuses to do so unless the County substantially increases the purchase price above the contract price. Therefore, the BCC should authorize the County Attorney to bring an appropriate court action to enforce purchases agreements and/or condemn the parcels of land needed for the Project. The proposed resolution is not limited to any particular parcel. It instead generally authorizes the County Attorney to bring such actions if negotiations fail or if another property owner refuses to abide by an executed purchase agreement. However, the resolution is limited to the Frenchy's Field to Siler Road Segment.

### **ACTION REQUESTED:**

Adopt the attached Resolution.

A RESOLUTION AUTHORIZING THE COUNTY ATTORNEY TO BRING CONDEMNATION AND OTHER APPROPRIATE COURT ACTIONS TO ACQUIRE PROPERTY INTERESTS NEEDED TO COMMENCE CONSTRUCTION OF THE SANTA FE RIVER GREENWAY PROJECT WITHIN THE FRENCHY'S FIELD TO SILER ROAD SEGMENT BY JULY 1, 2017

WHEREAS, since approximately 1995, the Santa Fe County (County) and the City of Santa Fe (City) have been engaged in planning, designing, and constructing a joint public works project called the Santa Fe River Greenway Project (Project), also known as the Santa Fe River Trail Project; and

WHEREAS, the Project calls for the City and County to construct approximately 15 miles of a continuous greenway comprised of parks and trails along the Santa Fe River from downtown Santa Fe to the City's Wastewater Treatment Plant west of NM599; and

WHEREAS, under a Memorandum of Agreement between the County and the City, the County agreed to acquire the necessary property interests for the Project within the Frenchy's Field to Siler Segment (Frenchy's Field Segment); and

WHEREAS, in order to timely complete the Frenchy's Field Segment before the end of the 2017 construction season, the County must commence construction by July 1; and

WHEREAS, the County cannot set a commencement date for construction or publish requests for proposals to construct the Frenchy's Field Segment until it has clear legal access to all necessary property interests within the Segment; and

WHEREAS, in order to expedite the property acquisition process, the Board of County Commissioners (Board) adopted Resolution No. 2014-125 to authorize the County Manager to acquire the necessary property interests through negotiated purchase agreements; and

WHEREAS, in accordance with Resolution No. 2014-125, the County Manager has acquired on behalf of the County or is under contract to acquire all necessary properties within the Frenchy's Field Segment except "Parcel 16," as identified in Resolution No. 2016-129; and

WHEREAS, as specifically authorized by Resolution No. 2016-129, the County Attorney commenced a court action to condemn Parcel 16 after multiple attempts to acquire it through negotiation had failed; and

WHEREAS, the County Attorney now requires additional authority to bring a condemnation or other appropriate court action to acquire two additional small parcels for the Project, in this case parcels that are subject to negotiated purchase agreements between the property owner and the County; and

WHEREAS, in order that construction may commence by July 1, the Board desires to delegate authority to the County Attorney to bring condemnation or other appropriate court actions to acquire the necessary property interests within the Frenchy's Field Segment whenever reasonable attempts to negotiate a purchase agreement fail or if necessary to enforce an existing purchase agreement.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby authorizes the County Attorney to initiate and prosecute condemnation or other appropriate court actions to acquire property interests within the Frenchy's Field Segment of the Project; provided, however, that no such action shall be brought until the County Attorney determines that reasonable attempts to acquire the property through negotiation have failed or that court action is needed to enforce an existing purchase agreement; and provided further that the County Attorney shall not initiate such an action, or shall seek to dismiss the action after initiation, if the property owner grants the subject property to the County in accordance with a negotiated purchase agreement.





### RESOLUTION NO. 2017-

## A RESOLUTION DELEGATING TO THE COUNTY MANAGER THE AUTHORITY TO NEGOTIATE AND EXECUTE A TOLLING AND RESERVATION OF RIGHTS AGREEMENT

WHEREAS, the Santa Fe County (County) Land Use Administrator has determined that (i) the Vista de Sangres Subdivision (Subdivision) was not approved in accordance with State law and County ordinance and, therefore, (ii) the Replat & Subdivision of Lot 11 Tracts 1, 2 and 3 for Vista de Sangres Subdivision (Plat) is not legally valid, although purportedly signed by a former Land Use Administrator; and

WHEREAS, although the developer of the Subdivision disputes the Land Use Administrator's determinations, the developer may be willing to make one or more applications to the County to have the Subdivision approved; and

WHEREAS, the developer is concerned that (i) such applications will be used by the County as an admission that the Plat is not valid and (ii) that the statute of limitations will continue to run on any claims the developer may have concerning the Plat; and

WHEREAS, if mutually acceptable terms can be negotiated, a tolling and reservation of rights agreement would allow applications to be made while addressing the developer's concerns and protecting the County's interests; and

WHEREAS, the Board of County Commissioners (Board) of the County desires to delegate to the County Manager the authority to negotiate and execute on behalf of the County a tolling and reservation of rights agreement.

### NOW, THEREFORE, BE IT RESOLVED by the Board as follows:

- 1. The Board hereby delegates to the County Manager the authority to negotiate and execute on behalf of the County a tolling and reservation of rights agreement that:
  - a. Tolls the further running of the statute of limitations on any claims that the County and developer may have against each other concerning the Plat for a period of time determined by the County Manager to be adequate for applications for approval of the Subdivision to be filed and acted upon;
  - b. Provides that the County will not use the fact of such applications as an admission by the developer that the Plat is not valid; and
  - c. Contains such other terms and conditions as the County Manager determines to be necessary or advisable to protect the County's interests.
- 2. This Resolution and execution of the tolling and reservation of rights agreement contemplated hereunder do not obligate the Board, any County recommending or decision making body, or County staff to approve or support any applications concerning the Subdivision, which shall be independently evaluated on their merits without regard to this Resolution or the tolling and reservation of rights agreement.
