SUMMARY:

This resolution directs staff to prepare and submit a Congestion Management and Air Quality Improvement (CMAQ) grant application to the New Mexico Department of Transportation (NMDOT) for the construction of improvement to Santa Fe County roads to address Americans with Disabilities Act (ADA) standards and authorizing the County Manager to execute any necessary documents to submit the grant applications to the NMDOT.

BACKGROUND:

The County's ADA Transition Plan (Transition Plan) was approved by BCC Resolution No. 2017-139 and submitted to NMDOT's Civil Rights Bureau on June 6, 2018. The Roads Element of the Transition Plan identified three project areas needing ADA transportation improvements: (1) Caja Del Oro Road (Agua Fria Street to La Familia Medical Center); (2) Rancho Viejo Blvd. (Hwy. 14 to Avenida del Sur); (3) Richards Avenue (Chili Line Road to A Va Nu Po).

The identified ADA transportation improvement projects for the three areas include: new bus stop concrete pads, new bus stop shelters, new benches, new sidewalks to the bus stops, relocation of barriers in the right-of-way, tactile warning strips, and intersection repaying.

The planned improvements will address five national transportation performance goals, including:

- 1. System Connectivity,
- 2. Infrastructure Condition,
- 3. Safety,
- 4. Congestion Reduction, and
- 5. Environmental Sustainability.

Application materials for the CMAQ Grants are due to the SFMPO by the end of October 2018. Applicants will be notified in March 2019 of the grant awards.

The table below summarizes project cost, local match, and maximum potential federal contribution:

Table 1: Estimated Construction Costs for ADA Transportation Improvements

ADA Transportation Improvements	\$500,000	\$85,206	\$585,206	

CMAQ grant is provided on a reimbursement basis and as such will require the County to provide all funds and then request reimbursement following completion of the work (or a portion of the work). The total project cost is \$585,206 and if the CMAQ grant is awarded, it will require a local match from the County of \$85,206

NMDOT will notify applicants of funding awards in March of 2019. Funding would be available in October of 2019.

STAFF RECOMMENDATION

Staff recommends approval of a Resolution declaring the eligibility and intent of Santa Fe County to submit an application to the New Mexico Department of Transportation (NMDOT) for the federal fiscal years 2020 and 2021 Congestion Management and Air Quality Improvement (CMAQ) program and acknowledging the availability of County funds for the 14.56% local match and reimbursable construction costs required by the CMAQ grant for improvement to Santa Fe County roads to address Americans with Disabilities Act (ADA) standards with a total project cost of \$585,206.00 and a potential county match of \$85,206.00 and authorizing the County Manager to execute any necessary documents to submit the grant application to the NMDOT.

WHEREAS, the Santa Fe County Americans with Disabilities Act Transition Plan (Transition Plan) was approved by the Board of County Commissioners (BCC) via Resolution No. 2017-139 and submitted to the New Mexico Department of Transportation (NMDOT) on June 6, 2018; and

WHEREAS, the Roads Element of the Transition Plan identified three project areas needing ADA transportation improvements: (1) Caja Del Oro Road (Agua Fria Street to La Familia Medical Center); (2) Rancho Viejo Blvd. (Hwy. 14 to Avenida del Sur); (3) Richards Avenue (Chili Line Road to A Va Nu Po); and

WHEREAS, the identified ADA transportation improvement projects for the three areas include: new bus stop concrete pads, new bus stop shelters, new benches, new sidewalks to the bus stops, relocation of barriers in the right-of-way, tactile warning strips, and intersection repaving; and

WHEREAS, the construction of the ADA transportation improvements is estimated to cost \$585,206; and

WHEREAS, should the CMAQ Grant be awarded, Santa Fe County acknowledges the availability of the required local match of \$85,206 for construction of the improvements and that the grant will be administered on a reimbursement basis; and

WHEREAS, Santa Fe County agrees to pay any costs that exceed the project grant amount if a grant is awarded; and

WHEREAS, Santa Fe County agrees to maintain the ADA improvements for the useable life of the project.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- The BCC hereby directs staff to complete and submit a CMAQ grant application to the NMDOT for Federal Fiscal Years 2020 and 2021 funding for the construction of ADA Transportation Improvements.
- 2. The BCC hereby assures the NMDOT that if CMAQ funds are awarded, sufficient funds will be available for the local match, plus reimbursable construction costs and any project costs that exceed the grant award amount, and all maintenance costs for the useable life of the project.






2. Richards Ave. @ Chili Line Rd. (Outbound)






