


#### **Background and Summary**

The Board of County Commission (BCC) adopted Resolution 2013-42 (Resolution) on April 30, 2013, establishing the Santa Fe County Water Policy Advisory Committee (Committee). The Committee was created for the express purpose of providing factual information to the BCC regarding water, wastewater, and water management within the County and regionally.

The Committee is comprised of twelve (12) voting members appointed by the BCC and members shall reside within the exterior boundaries of Santa Fe County. Specifically, Article 7 of the Resolution established the memberships as follows:

- a. One committee member shall be from a mutual domestic water consumers' association;
- b. One committee member shall be from a soil and water conservation district;
- c. One committee member shall be a member of an acequia association;
- d. One committee member shall be from the Estancia Basin Water Planning Committee;
- e. One committee member shall be from the central water planning area;
- f. One committee member shall be from the northern water planning area;
- g. One committee member shall be the public member of the Buckman Direct Diversion Board;
- h. The balance committee members shall be chosen by commissioners from their respective districts.

#### Additionally, Article 7 provides that:

Membership should span a wide range of expertise and experience not limited to water. Expertise may be demonstrated by membership in an established community water group; by professional practice in the field of water, wastewater, hydrology, agriculture, or similar; or by other documented relevant professional or volunteer experience. Individuals with expertise in the water policies and practices of other governmental entities in the region are also qualified to serve on the Committee. Interested residents must submit a letter of interest and documented qualifications. In the event more than one individual seeks appointment to a position on the Committee, the Public Works Department will be asked to rank the competing applicants.

Upon receipt of applications, staff will undertake the necessary review and provide for BCC consideration.

RESOLUTION NO. 2013-42

#### A RESOLUTION ESTABLISHING A WATER POLICY ADVISORY COMMITTEE

WHEREAS, the Board of County Commissioners seeks to create and maintain a coherent water policy that encompasses the full spectrum of water use and meets, to the extent possible, the needs of all water users;

WHEREAS, the County's Sustainable Growth Management Plan identifies water as an important County matter and in particular lists seven key water issues and eight keys to sustainability that will require a full community effort to address or implement;

WHEREAS, the County has numerous existing water policy documents that require occasional updating and cross-referencing;

WHEREAS, Resolution 2011-88 requires that a water focus group be convened to discuss aquifer storage and recharge (ASR) when the County begins to address this issue;

WHEREAS, it is in the interest of all residents of Santa Fe County to address water issues in a regional manner, including utility water service, source of supply, irrigation, and water reuse;

NOW, THEREFORE BE IT RESOLVED by the Board of the County Commissioners (BCC) that:

- 1. A Water Policy Advisory Committee (the Committee) is hereby created for the express purpose of providing factual information to the BCC regarding water, wastewater, and water management within the County and regionally.
- 2. The Committee shall be comprised of 12 voting members appointed by the BCC.
- 3. Six members of the Committee will be appointed for an initial term of two years and six members shall be appointed for an initial term of three years. Thereafter Committee members shall serve terms of three years. In the event of a vacancy, the BCC shall appoint a member to serve out the remainder of the departing member's term, taking into consideration any recommendation from the Committee and Public Works staff to fill that vacancy. There shall be no limitation on the number of consecutive terms that a member may serve. Members may be removed by the BCC with or without cause.



- 4. Committee members shall annually elect a chair and a vice-chair by majority vote of the quorum.
- 5. The Committee shall meet as often as necessary to carry out its work, but no less than quarterly. The meetings of the Committee shall be held in the County Public Works facility and such other locations as may be conducive to visible and publicly accessible meetings. Meetings shall be held in accordance with all relevant County policies with regard to public notice, open meetings, and rules of order.
- All matters coming before the Committee shall be resolved by majority vote of the quorum.
- 7. All Committee members shall reside within the exterior boundaries of Santa Fe County.
  - a. One committee member shall be from a mutual domestic water consumers' association;
  - b. One committee member shall be from a soil and water conservation district;
  - c. One committee member shall be a member of an acequia association;
  - d. One committee member shall be from the Estancia Basin Water Planning Committee;
  - e. One committee member shall be from the central water planning area;
  - f. One committee member shall be from the northern water planning area;
  - g. One committee member shall be the public member of the Buckman Direct Diversion Board:
  - h. The balance of the committee members shall be chosen by commissioners from their respective districts.

Membership should span a wide range of expertise and experience not limited to water. Expertise may be demonstrated by membership in an established community water group; by professional practice in the field of water, wastewater, hydrology, agriculture, or similar; or by other documented relevant professional or volunteer experience. Individuals with expertise in the water policies and practices of other governmental entities in the region are also qualified to serve on the Committee. Interested residents must submit a letter of interest and documented qualifications. In the event more than one individual seeks appointment to a position on the Committee, the Public Works Department will be asked to rank the competing applicants.

- 8. The County Manager shall appoint a member of the County Staff to serve as liaison to the Committee.
- 9. The scope of duties of the Committee shall include the following:
  - a. To make recommendations related to water policies in the County land development code, with focus on making recommendations in areas such as: land restoration practices and techniques that lead to water collection, restoration, and conservation; implementation of grey water and closed re-circulating systems; agricultural land

- restoration; protection of waterways such as the Santa Cruz River, within existing water resource allocations; etc.
- b. To make recommendations related to County water and wastewater utility growth;
- c. To assist the County in addressing proposed aquifer storage and recharge activities, design plans, and projects;
- d. Explore the concept of an independent regional water authority or authorities, including interfacing with the City of Santa Fe, the City of Espanola, the Town of Edgewood, mutual domestic water consumer associations, and other regional water users regarding a regional water authority or authorities;
- e. Recommend updates to the current 40-year Water Plan, the Conjunctive Management Plan, or other plans;
- f. Such other water related topics and issues as directed by the BCC.
- g. Identify and flag applications for appropriations that affect the County.
- 10. Within two months of the creation of the Committee and at the second BCC meeting in January of each year thereafter, the chair of the Committee shall present to the BCC for approval a draft work plan for the upcoming calendar year or portion thereof. The work plan shall include a list of tasks or topics to be addressed by the Committee over the year along with a delivery schedule of updates, reports, and other deliverables. The chair may from time to time amend this work plan with approval from the BCC. The BCC can amend this work plan at any time. The chair shall update the BCC in accordance with this work plan.
- 11. The Committee may be incorporated into other County standing committees or otherwise dissolved at any time.





**Issue:** The reappointment of three individuals and the appointment of four new individuals to serve as trustees at various Santa Fe County Community Centers.


#### Background

The Community Services Department is requesting the appointment of four new people who responded to the ad for new trustees. All of these individuals completed the paperwork and passed the background check. They are as follows:







# **Background and Summary**

The City of Santa Fe passed adopted Resolution 2016-7 (Resolution) which created the Santa Fe Film Commission (Commission) and provides stated support of economic development and job creation in film and digital media.

The purpose of the Commission is to review and make recommendations to the Governing Body of the City of Santa Fe as it relates to film production in and around the City of Santa Fe. Specific duties and responsibilities of the Commission shall be to establish priorities in its operation that work towards the following goals:

- Enhance recognition as a desirable filmmaking destination and increase production in Santa Fe
- Increase post-production and other digital media business as a sustainable industry in Santa Fe
- Diversify the industry base by growing local productions and other complimentary businesses in Santa Fe
- Foster a sustainable year-round industry that employs a skilled workforce in high-wage jobs
- Facilitate increased production spending at local businesses
- Evaluate potential areas of investment and resource allocation and make recommendations on priorities

As provided for in the Resolution, the membership is comprised of four local industry leaders, two film crew representatives, three representatives form educational institutions, two representatives form digital media businesses, two representatives from non-profits working in the industry, one representative from the County of Santa Fe as chosen by the Santa Fe County Commission, and two at-large representatives.

### Recommendation

Although staff fielded inquiries for the appointment, staff only received one resume for consideration. Staff is therefore recommending the appointment of Ms. Susan Fiore as the Santa Fe County Representative on the City of Santa Fe's Film Commission.

WHEREAS, the City Film Liaison has issued approximately 60 permits per year for the last three years creating not only jobs, sales and rentals, but millions of dollars of free publicity that has propelled Santa Fe to new heights of international recognition while maintaining a cordial relationship and respect for the businesses and neighborhoods where the filming was permitted; and

WHEREAS, in 2013 Santa Fe County received 16 permits for film and TV productions, and under those permits, payroll exceeded \$20 million for local hires; and

WHEREAS, in 2013, direct spending from major productions totaled over \$50 million with more than 200 local businesses providing services to the film industry, for an overall estimated economic impact of \$160 million; and

WHEREAS, the State of New Mexico released a Film Production Tax Incentive (FPTI) Study in July 2014 which found that between 2010 and 2014:

- Total economic output generated by productions was \$1.53 billion
- Gross State Product (GSP) generated from production spending was \$968.9 million
- Total revenue from state and local taxes on production reached \$103.6 million

maximum three terms. After three consecutive unexcused absences a commission member shall be automatically removed and notified thereof by the chairperson.

Section 6. VACANCIES: Vacancies on the Santa Fe Film Commission shall be filled in the same manner as initial appointments and shall be for the remainder of the unexpired term. Any member of the commission may be removed by the mayor with the approval of the Governing Body, with or without cause.

Section 7. MEETINGS: A quorum shall be a majority of the whole membership. The Commission shall meet at least once per month and shall conduct public meetings in accordance with the Open Meetings Act and adopted city policies and procedures.

Section 8. STAFF LIAISON: The Economic Development Department Director, or his or her designee, shall serve as the primary liaison to the Santa Fe Film Commission. The Director may appoint another staff member to assist with operation of the Santa Fe Film Commission.

BE IT FURTHER RESOLVED, The Santa Fe Film Commission shall prioritize tasks and develop a plan for carrying out its Purpose, and Duties and Responsibilities as set forth in Sections 2 and 3, and cost estimates within six months of being appointed by the Governing Body. The Commission shall oversee the implementation of the work-plan and provide guidance, strategy, identify connections in the industry, and other relevant and pertinent priorities.

BE IT FURTHER RESOLVED, that six (6) and twelve (12) months from appointment, the Commission will report to Governing Body on the progress made, lessons learned, and recommendations for next steps.

BE IT FURTHER RESOLVED that \$50,000 shall be the initial budget for the Santa Fe Film Commission to recommend allocating in targeted areas in order to execute its mission
