#### Overview

The HR Division provides the Santa Fe County Board of County Commission with a monthly report regarding highlighted HR information and events. The purpose of this memo is to provide you with information for the month of March.

## Training and Employee Development

Throughout the month of March, Human Resources conducted/coordinated 16 training sessions that included the attendance of 234 employees and 284 employees completed online training sessions. In addition, HR also conducted/coordinated 2 supervisory training sessions that included the attendance of 23 supervisory employees.

Human Resources also processed 55 NM EDGE applications for a total of 230 courses which will be offered to Santa Fe County employees.

## **Employee Benefits and Wellness**

Human Resources is beginning the 3<sup>rd</sup> Annual One Million Steps Challenge. This challenges employees to walk a million steps by October 31, 2018. In order to reach the 1 million steps at the end of the 7 months, the daily step goal totals 4,673 per day. Using a pedometer, smartphone app or Fitbit, employees log their daily steps and calculate the total number of steps for the month, at the end of the month. A new component has been added into this challenge which will allow employees who participate in it will be provided administrative leave to become "Trail Ambassadors". The "trail ambassadors" will meet monthly on the second Wednesday of each

month and will hike for 1 hour. There will be a monthly drawing for employees who submit their steps on time and a drawing at the end of the challenge for all participants who meet the challenge goals.

#### **Promotions and Recruitment**

During the month of March, testing was conducted for Detention Officer, Sheriff Cadet and Emergency Communication Specialist Trainee. Eleven (11) applicants participated in Detention Officer testing. Fourteen (14) applicants participated in Sheriff Cadet testing. Five (5) applicants participated in Emergency Communication Specialist Trainee testing.

The County had four (4) promotions during the month of March.

In the Public Safety Department/Administration, one (1) employee advanced to a higher position:

• Domitila Rendon-Varela began working for Santa Fe County on June 19, 2000 and progressed from an Administrative Manager to Operations Manager.

In the Sheriff's Office, two (2) employees advanced to a higher position:

- Paul Colombe began working for Santa Fe County on March 9, 2015 and progressed from a Sheriff Deputy III to Sheriff Corporal.
- Oliver McCartney began working for Santa Fe County on February 20, 2017 and progressed from a Sheriff Deputy II to Sheriff Deputy III.

In the Public Safety Department / Corrections, one (1) employee advanced to a higher position:

• Richard Roybal began working for Santa Fe County on July 11, 2011 and progressed from an Adult Detention Officer Sergeant to Adult Detention Officer Lieutenant.


