SUMMARY

This is a request to approve the appointment of five (5) members to the Capital Improvements Advisory Committee (CIAC) to assist in the update and establishment of impact fees, in accordance with the Development Fees Act.

BACKGROUND

On August 28, 2018, staff presented the Fire Impact Fee review and renewal process to the Board. The Fire Impact Fee was adopted by Ordinance 1995-04 as a fee on new development to partially fund growth related capital requirements for fire and emergency response services in the County. The New Mexico Development Fees Act requires that Impact Fees are updated every five years. The Fire Impact Fee was last renewed in 2013.

Santa Fe County Resolution 2013-73 established the County's CIAC. The Development Fees Act also requires that Santa Fe County appoints a Capital Improvements Advisory Committee (CIAC) to:

- Assist the County in adopting land use assumptions
- Review the CIP and file written comments
- Monitor and evaluate the implementation of the CIP and file annual reports
- Advise the County of the need to update or revise the land use assumptions, CIP, or impact fee

The CIAC must have at least five (5) members with at least forty (40) percent of members representing the real estate, development, or building industries.

Staff placed advertisements in the Santa Fe New Mexican and the Albuquerque Journal North requesting volunteers for the CIAC. Additionally, staff posted notices on the County's website and issued press releases notifying the public of the request for volunteers to serve on the committee.

As of the date of this memo, staff has received five (5) letters of interest and is reviewing these applications for CIAC members. A summary of the applicants and their backgrounds is provided below. The applicants' resumes and letters of interest in serving on the committee are attached with this memo.

I was a recipient of an Outstanding Employee Award for Teamwork in 2012 for working with a group of VDOT employees on drafting and implementing the Chapter 870 (legislation pertaining to secondary street acceptance, access management, land use permits and traffic impact analysis).
- Senior Project Manager with ATCS, PLC. I was the senior project manager for the transportation planning division of the ATCS in their Sterling, VA office. I supervised the work of as many as six planners and engineers working on a variety of projects. This project included a series of six (6) neckdowns or chokers that effectively reduced the speed of vehicles traveling along this heavily traveled route.
