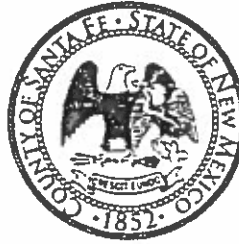

Resolution 2015 - _____ A Resolution Requesting a Budget Increase to the State Special Appropriations Fund (318) to Budget a Grant for the Pojoaque Sports Fields in Pojoaque in Santa Fe County. / \$128,800 (Finance/Teresa Martinez)

SUMMARY:

The purpose of this resolution is to budget Grant 14-L-1997 in State Special Appropriation Fund (318) in the amount of \$128,800 to purchase and/or make improvements to the Pojoaque Sports Fields in Pojoaque in Santa Fe County.

BACKGROUND:

In June 2012, the Board of County Commission approved the 2012 Capital Improvement Plan which included \$1,000,000 in GRT and GOB funds to purchase and make improvements to the Pojoaque Sports Fields. In addition, the County allocated \$855,666 in GRT funding from various sources including the Rancho Valle Project (\$70,000), the Northern NM Rec Fields (\$490,500) and District 1 Capital funds (\$295,166). Santa Fe County also received two legislative grants to purchase and/or make improvements to the Pojoaque Sports Fields; Grant 13-1765 in the amount of \$225,000 and Grant 14-1997 in the amount of \$128,800. The total project budget for the Pojoaque Ball Fields is \$2,209,466. All funds are budgeted with the exception of Grant 14-1997 in the amount of \$128,800.

ACTION REQUESTED:

Public Works is requesting approval to budget Grant 14-L-1997 in the amount of \$128,800 to make improvements to the Pojoaque Sports Fields.

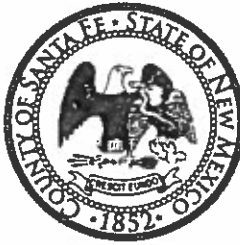

AUTHORIZING THE COUNTY MANAGER TO APPLY FOR AND ACCEPT
HIDTA GRANTS.**

Background and Issue. In 2014 HIDTA Grant G14SN0011A was originally awarded for the amount of \$255,013.00. The County Manager signed the acceptance of that grant amount on behalf of Santa Fe County, Region III Drug Trafficking Enforcement Program. By Modification 1 HIDTA Grant G14SN0011A was supplemented by a \$66,800 additional grant of funds. The supplemental grant acceptance was signed by the County Manager. The County Region III has been awarded another supplemental grant of \$8,000 making the total for HIDTA Grant G14SN0011A \$329,813.00. The Board must approve the supplemental grant of \$8,000 and ratify the Manager's signature acceptance of the original grant and previous supplemental grant of \$66,800.

Implementation of this grant funding would be more efficient if the County Manager is authorized to apply and accept these HIDTA grants. This resolution proposes to have the Board delegate this authority to the County Manager.

Proposed Resolution. The proposed resolution would:

- o Accept the supplemental grant of \$8,000 and ratify the County's acceptance of the the original grant of \$255,013.00 and the supplemental grant of \$66,800.
- o Delegate to the County Manager the authority to apply for and accept all HIDTA grants.

Recommendation. Approve the resolution.

WHEREAS, in April 2014 the County was the recipient of HIDTA grant G14SN0011A in the amount of \$255,013.000 from the HIDTA Program; and

WHEREAS, in September 2014, by Modification 1 to the HIDTA G14SN0011A grant, the County was awarded a supplemental amount of \$66,800.00 for a total HIDTA G14SN0011A grant amount of \$321,813.00; and

WHEREAS, by Modification 2 the HIDTA Program has awarded the County a supplemental grant in the amount of \$8,000.00 for a total HIDTA grant amount of \$329,818 for FY 2015.

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners of Santa Fe County hereby ratifies the HIDTA G14SN0011A grant acceptance in the amount of \$255,013.00 and the supplemental grant in the amount of \$66,800.00 signed by the County Manager, and approves the supplemental award (Modification 2) in the amount of \$8,000.00 for a total HIDTA grant amount of \$329,813.00. Furthermore, the Board of County Commissioners delegates to the County Manager the authority to apply for and accept all HIDTA grants, on behalf of the Santa Fe Board of County Commissioners.

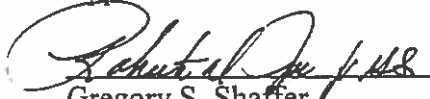
