### **BACKGROUND/SUMMARY**

Each year millions of Americans face the reality of living with a mental health condition. During the first full week of October, participants across the country raise awareness of mental illness. Each year they fight stigma, provide support, educate the public and advocate for equal care.

One in 5 adults experiences a mental health condition every year. One in 17 lives with a serious mental illness such as schizophrenia or bipolar disorder. In addition to a person's directly experiencing a mental illness, family, friends and communities are also affected.

Half of mental health conditions begin by age 14, and 75% of mental health conditions develop by age 24. The normal personality and behavior changes of adolescence may mimic or mask symptoms of a mental health condition. Early engagement and support are crucial to improving outcomes and increasing the promise of recovery.

## A PROCLAMATION RECOGNIZING OCTOBER 2 TO OCTOBER 8, 2016, AS MENTAL ILLNESS AWARENESS WEEK

WHEREAS, October 2-8, 2016, is designated as National Mental Illness Awareness Week;

WHEREAS, one in five adults experience a mental health problem in any given year and one in 17 adults live with a mental illness such as major depression, bipolar disorder or schizophrenia;

WHEREAS, approximately fifty percent of those living with chronic mental illness experience symptoms by the age of 14 and three-quarters by the age of 24;

WHEREAS, mental illnesses are real and prevalent in our nation;

WHEREAS, approximately two-thirds of all inmates in the county jail have unmet behavioral health needs;

WHEREAS, with early and effective treatment, those individuals with mental illnesses can recover and lead full and productive lives;

WHEREAS, long delays, sometimes decades, often occur between the time symptoms first appear and when individuals get help;

WHEREAS, early identification and treatment can make a difference in successful management of mental illness and recovery;

WHEREAS, it is important to maintain mental health and learn the symptoms of mental illness in order to get help when it is needed;

WHEREAS, the Health Policy and Planning Commission has made behavioral services, including a triage center for mental illness, a high priority in the County Health Action Plan;

WHEREAS, should General Obligation Bond Question No. 5 be approved by the voters, one of the projects that Santa Fe County currently anticipates funding with bond proceeds is the Santa Fe County Behavioral Health Crisis Triage Center; and

WHEREAS, the County Advisory Question to Enact a Countywide Gross Receipts Tax for Behavioral Health Services on the 2016 General Election Ballot gives voters in Santa Fe County the opportunity to advise the Board of County Commissioners (BCC) of Santa Fe County whether they support the enactment of a countywide gross receipts tax for behavioral health services that would increase the aggregate gross receipts tax rate by up to one-eighth of one percent (0.125%).

NOW, THEREFORE BE IT PROCLAIMED by the Board of County Commissioners of Santa Fe County that the week of October 2 – 8, 2016 is Mental Illness Awareness Week.

BE IT FURTHER PROCLAIMED that Santa Fe County citizens are encouraged to consider how mental illness affects all of us and how the community can best deal with this issue.

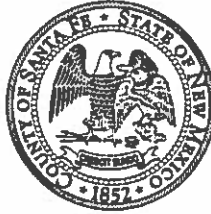

### BACKGROUND/SUMMARY

In 2012 Santa Fe County partnered with the National Park Service National Trails Office to develop conceptual designs for gateway entrances to the Historic Village of Agua Fria. The gateways will be located on Agua Fria Street, the original route of El Camino Real de Tierra Adentro, a federally designated National Historic Trail by the U.S. Congress. This project was initiated by the Village of Agua Fria during the planning process to develop the Agua Fria Community Plan adopted in July of 2008. The County has worked closely with the Village of Agua Fria to develop the gateway entrances.

The goal of the gateway entrances is to communicate to travelers that they are entering a historic village on El Camino Real. The gateways will capture the special character of Agua Fria Village. A secondary goal of the gateways is to calm and slow traffic as it enters the Village.

This proclamation acknowledges the contributions of civic participation and public betterment of the citizens of Agua Fria Village. The community came together to partner with Santa Fe County in creating a boundary marker at the north end of the Traditional Village.

### **BACKGROUND**

On the agenda for your consideration is a proclamation proclaiming October 16, 2016 as "World Food Day in Santa Fe County."

World Food Day is a global celebration on October 16<sup>th</sup> each year, to promote awareness of the importance of food security and the need to make nutritious food available to all. In 2014, the Board of County Commissioners approved the food plan prepared by the Santa Fe Food Policy Council, *Planning for Santa Fe's Food Future: Querencia, a Story of Food, Farming, and Friends*. Progress since then is described in the 2015 Santa Fe Food Plan Progress Report, and also includes the *Santa Fe County Agriculture and Ranching Implementation Plan*, approved by the BCC in July 2016.

World Food Day 2016 is focused on climate change, agriculture, and hunger and provides an excellent opportunity to celebrate our heritage of local agriculture and food and to recognize local groups working to address hunger and food security, including the Food Depot, Kitchen Angels, Farm to Table, Feeding Santa Fe, Bienvenidos Outreach, Cooking with Kids, Earth CARE, the Institute for American Indian Arts, the Santa Fe Farmers Market and Institute, La Familia Medical Center, and the Santa Fe County Cooperative Extension Office.

WHEREAS, World Food Day is a global celebration on October 16th to promote awareness of the importance of food security and the need to make nutritious food available to those who suffer from hunger; and



# 2015 SANTA FE FOOD PLAN PROGRESS REPORT

The Santa Fe City and County Advisory Council on Food Policy (SFFPC) released the Santa Fe Food Plan “Planning for Santa Fe’s Food Future: Querencia, a story of food, farming, and friends” (Food Plan) in October of 2014. The Food Plan proposes several goals to make it easier for residents in Santa Fe City and County to Get Food, Learn about Food, and Grow Food. Over the past year, our community has taken steps toward meeting the goals in the Food Plan. This report highlights these substantive accomplishments, first steps, and movements toward success.

The City of Santa Fe made key steps toward increasing food security and increasing access to getting and growing food as a result of work by the Mayor’s Climate Action Task Force, including a renewed push to promote and codify urban agriculture. Santa Fe County completed a new zoning process which has resulted in the 2015 Sustainable Land Development Code (SLDC), and also created the 2015 Sustainable Growth Management Plan which includes specifics on issues surrounding food, land use, and agriculture in the County. In addition, the SFFPC worked with key partners to provide comments on the 2015 Federal Dietary Guidelines, to celebrate World Food Day in Santa Fe, and to support key legislation at the local and state levels, including Double Up Food Bucks for Farmers Markets, the NM Grown Fresh Fruits and Vegetables for School Meals Program, and the federal Farm to School Act.

We realize there is much left to do to meet the goals in the Food Plan, especially in meeting the needs of our most vulnerable citizens. We intend this update to serve not only as a report of our progress, along with many who have committed their time and resources to these endeavors, but also as a push for all of us to continue to work together to create safe, healthy, and productive communities. Thanks to those who continue to fight to end hunger, protect our lands, and foster our ability to access, learn about, and grow food in Santa Fe City and County.

## GETTING FOOD

### **GOAL 1: Improve residents’ ability to access fresh, nutritious food.**

- Mayor’s Climate Action Task Force Subcommittee on Water, Land Use, and Food Security created recommendations to the City of Santa Fe encouraging (1) the creation of a permanent Southside Farmers’ Market, and (2) better alignment of transportation routes with fresh food outlets in the City. These recommendations have been submitted to the City Council for consideration.
- Feeding Santa Fe, Inc., as a part of the weekly distribution of grocery bags for their emergency food assistance program, has significantly increased quantities of fresh fruits and vegetables through monthly, year-round wholesale purchases and their “Grow a Row” initiative whereby local gardeners contributed items from their home gardens. The Santa Fe Community Farm also shared many bags of fresh vegetables during the growing season. In partnership with NM State University, Santa Fe ICAN nutrition educators included healthy recipes, food safety, and nutrition information—in both English and

Spanish—in food bags. Relationships were also developed with Head Start for their Home Visiting Program and Santa Fe County's Health and Human Services Division for at-risk seniors.

- La Familia Medical Center's (LFMC) Healthy CENA (*Comunidad, Ejercicio, Nutrición y Acción*) Program collaborates with MoGro to provide a weekly community supported agriculture-style food program for their patients. MoGro boxes included 10 organic fruits and vegetables weekly, and are offered to patients for \$10 if they receive SNAP benefits (\$20 cash). Through the Healthy CENA Program, La Familia Medical Center also offers monthly gardening workshops for patients at their Alto Street clinic.
- The SFFPC met with the Governor and Tribal Leaders of the Tesuque Pueblo to begin a dialogue on food access for seniors and children, protecting and promoting agriculture and gardening on Tesuque Pueblo, water rights issues and environmental concerns, and to learn more about the innovative approaches being taken by Tesuque Pueblo to meet community needs.

**GOAL 3: Prioritize getting local, fresh food into schools.**

- The SFFPC advocated for NM Grown Fresh Fruits and Fresh Vegetables for School Meals program, and secured \$463,000 in funding for FY 2016. Based on enrollment, Santa Fe Public Schools received \$15,563, Santa Fe Indian School received \$660, NM School for the Deaf received \$120, and Moriarty-Edgewood Schools received \$2,702.
- Santa Fe Public Schools purchased \$50,000 in local food, above and beyond the fund allocated by the NM Grown Fresh Fruits and Fresh Vegetables for Schools Meals program.
- The SFFPC initiated discussion about universal free school meals, and universal free meal per day with the City through City of Santa Fe Resolution 2015-39 "A Resolution Relating To Child Hunger; Proclaiming Support For Community Efforts To Ensure That All Children Ages 0-18 Are Able To Access At Least One Healthy Meal Per Day."

**GOAL 4: Promote existing food assistance programs.**

- The SFFPC reviewed and provided comment to the United States Department of Agriculture and to the United States Department of Health and Human Services in support of the 2015 Dietary Guidelines Advisory Committee's proposed "Scientific Report of the 2015 Dietary Guidelines Advisory Committee". Most of the dietary recommendations in the initial report were approved and are included in the final 2015-2020 Federal Dietary Guidelines, including the recommendation to eat less meat and less sugar. The SFFPC supported an important section in the initial Proposed Guidelines linking environmental sustainability to diet, which was not included in the final Federal Dietary Guidelines update.
- The SFFPC advocated at the 2015 NM State Legislature in support of the "Double Up Food Bucks" program which doubles the amount of money that Supplemental Nutrition Assistance Program (SNAP) recipients have to spend on fresh fruits and vegetables at farmers' markets in NM. The program received a statewide budget allocation of \$400,000. In the first year of the program's implementation, participating markets in Santa Fe City and County saw a 66% increase in SNAP sales from 2014 to 2015, with

\$50,789 in revenue from SNAP and Double Up Food Bucks sales going to local producers in 2015.

- The SFFPC opposed New Mexico Human Services Department (HSD) proposal to expand the work requirements for Supplemental Nutrition Assistance Program (SNAP) recipients, which would make it more difficult for individuals to maintain their benefits. The proposal also was not funded to expand the amount of case workers necessary to enforce and monitor the expansion of requirements for NM SNAP recipients.

**GOAL 5: Celebrate local food and support regional food economy.**

- The SFFPC, along with more than 25 community partners, hosted the first World Food Day in Santa Fe on October 16<sup>th</sup>, 2015 as a celebration of our agricultural heritage, of the individuals and organizations who work day in and day out to end hunger and bring justice to our community, and of the bountiful harvest we share in Santa Fe. This was coordinated by the Education and Outreach Committee of the Council.

## **LEARNING ABOUT FOOD**

**GOAL 1: Expand opportunities for creative and experiential learning through cooking and nutrition.**

- A new effort began with the Food Depot, Adelante, Cooking with Kids, NM State University ICAN Supplemental Nutrition Assistance Program (SNAP) Educators, the Santa Fe Farmers' Market Institute, and others to host collaborative family cooking classes which focus on preparing meals from scratch using real food.
- Farm to Table NM worked with NM School Food service directors, New Mexico State University Cooperative Extension, the National Farm to School Network, and the United States Department of Agriculture to develop and coordinate food safety guidelines for schools to purchase from farmers and for farmers to sell to schools.

**GOAL 3: Expand and Diversify opportunities to access food assistance.**

- The NM Income Support Division conducted outreach at the Southside Farmers Market, including information about SNAP, WIC, and other benefits to make food more accessible to low-income community members.
- The SFFPC initiated the first of what will hopefully be many conversations with the Tribal Leaders of Tesuque Pueblo to discuss partnerships around food access for elders and children, water rights, and the nexus of food and health.

**GOAL 4: Align and publicize wellness policies throughout the Santa Fe region.**

- Santa Fe Public School's School Health Advisory Council has reconvened in partnership with the NM Department of Health, with increased efforts to update and develop new wellness policies.

## **GROWING FOOD**

### **GOAL 1: Increase the impact and efficiency of community gardens.**

- The Community Garden Task Force conducted an evaluation of the City of Santa Fe's publicly held community gardens, and generated a report citing the successes and challenges to helping best serve Santa Feans. Their report outlined recommendations for increased efficiency and clarity of garden management, which were passed on to the City of Santa Fe for consideration.
- La Familia Medical Center helped create the Community Garden Council, a coordinated group of community gardeners, through funding from the Con Alma Healthy People, Healthy Places program.

### **GOAL 4: Conserve water through educational programs, incentives, and policies.**

- A comprehensive set of recommendations on water use and conservation were proposed through the Mayor's Climate Action Task Force Water Land Use and Food Security Subcommittee, and encompassed water table restoration, stream management, and budgetary considerations for funding future conservation projects.

### **GOAL 5: Increase the viability and presence of local gardens, farms, and ranches.**

- Santa Fe County underwent an extensive and comprehensive planning process in 2015 which resulted in the 2015 Sustainable Growth Management Plan (SGMP). This process facilitated community conversations and updates to community plans to include and protect agricultural heritage and support future agricultural development, which are reflected in Chapter 4 of the 2015 SGMP.
- The City of Santa Fe developed a team of community stakeholders, reviewed nation-wide best practices, and sought community input on a set of urban agriculture ordinances and an accompanying program to explicitly support and protect the ability of Santa Feans to produce and sell food within Santa Fe City limits. The ordinance is expected to be seen before the Santa Fe City Council in early 2016.
- Santa Fe County staff is developing an Agriculture and Ranching Implementation Plan to support the 2015 Sustainable Growth Management Plan, as directed in Resolution 2016-5. Focus areas of the Plan include promoting an agricultural clearinghouse that connects County landowners with farmers and ranchers who need land, and another area of focus relates to developing a systematic approach to supporting agricultural use on County Open Space properties.

### **GOAL 6: Develop agricultural incentives and innovative programs to support small farmers and maximize food production/distribution in our regional foodshed.**

- The SFFPC's Food Production & Land Use Committee has created a cross-sector team of experts from Santa Fe County government, the City of Santa Fe government, City and County nonprofit organizations, and other state-wide partners to review and develop policy initiatives and incentives for preserving agriculture, encouraging growth in the agricultural sector, conserving and protecting agricultural lands, and many other land use related issues. The Committee worked with Santa Fe County to support a draft



resolution to create an Agriculture and Ranching Implementation Plan in 2016, which could bring about several new incentives for farmers, ranchers, and land owners including a potential agricultural clearinghouse that connects County Landowners with farmers/ranchers in need of land.

- Santa Fe County completed a comprehensive zoning process which has resulted in the 2015 Sustainable Land Development Code (SLDC). The SLDC establishes a Transfer of Development Rights (TDR) Program which allows property owners to sell their development rights in order to protect agricultural and other valuable lands in the County and directs development to appropriate areas within the County.
- Santa Fe County has created a density bonus option, which allows property owners to receive density bonuses to protect contiguous open space by encouraging clustered development.
- Santa Fe County is supporting agriculture through the elimination of permit fees for agricultural accessory structures on lands where the primary use is agriculture, grazing or ranching.

**GOAL 8: Prioritize sustainability and agriculture in future development in Santa Fe City and County.**

- Communities in Santa Fe County were able to determine how agricultural land uses would be regulated within their community planning districts, in accordance with their adopted Community Plan's vision. Santa Fe County worked with communities to update 13 Community Plans and created Community District Overlays which allowed these communities to determine the way a variety of land uses would be regulated in the 2015 Sustainable Land Development Code.

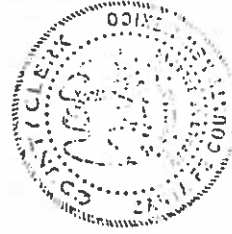

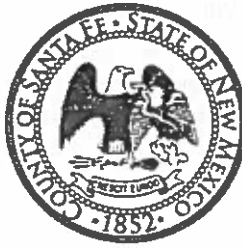

**ITEM AND ISSUE: Update on Highway 14 Senior/Community Center  
(Public Works/ Mark Hogan)**

---

**SUMMARY:**

The Highway 14 Senior/Community Center has been in the Property Acquisition and Development process since August 11, 2015 when the site in the Cerrillos community was identified as the preferred property to develop after an extensive effort to find a suitable location for the facility. The purchase of the property was completed January 8, 2016.

In November of 2015 a RFP for Architectural Services was drafted and in December the project was advertised. In March 2016 proposals were evaluated and a highest ranking team identified on April 28, 2016. Negotiations with the highest ranked team, Autotroph Inc. began thereafter and a contract was submitted for County approval on September 6, 2016. Currently the Projects Division is expecting the Purchase Order for the Autotroph contract so that the programming of the Project can be initiated.

During the contract negotiations the Project Manager for the County, Ron Sandoval, began a dialog with members of the Cerrillos Community and has established a stakeholder register which has been used to provide updates to those on the register. There are a minimum of three Public Meetings included in the architect's Contract.

The first Public Meetings will be with the Community during the Programming Phase which is designed to collect input from the Community and the User Agency (Community Services) to establish the specific requirements for the building as well as the input from the Community on issues and preferences that they feel are important.

Additional public meetings will occur when a schematic design is developed so the community can have a look at the design and have input in the early phases of development and then again when the design is complete and the details of construction can be discussed. This meeting is critical to anticipate any impacts on local residents that can be planned for to minimize problems during the construction process.

**BACKGROUND:**

Residents in the town of Cerrillos have expressed interest in the Senior/Community Center project and wish to be informed of progress and have the opportunity to contribute to the design and development of the Center.
