

By all respects to the dead, my role was to care take and escort the human remains of Victims of Crime to OMI and stay with them until their autopsies were completed. I never left them alone.

I volunteer and serve at the St. Anne's Catholic Church in Santa Fe, NM. As part of the Knights of Columbus mission and objectives, we work to help the poor and needy during the holidays, including assisting our parish priest with whatever he needs for the parish community. It is definitely an honor to serve and assist from a faith-based perspective. The Knights of Columbus was formed by Father Michael McGinney in 1882 to form a group of practical Catholic men who would look after Catholic widows and orphans. The Knights was formed to rendered financial aid to members and their families. Mutual aid and assistance are offered to sick, disabled, and needy members and their families. Social and intellectual fellowship is promoted among members and their families through educational, charitable, religious, social welfare, war relief and public relief works.

As an independent lobbyist, I have worked on the various introduction of legislative bills that genuinely reflect and represent the true New Mexico that I live in from a grass root level. In addition, I have drafted and introduced the language and content of HB 30 - Unborn Victims of Violence Act in (2011) and HB 84 (2013). These two bills relating to criminal law; creating crimes against unborn children; enacting the unborn victim of violence act in memory of Little Isaac; repealing and enacting sections of the criminal code; providing penalties. Most of the legislative bills that I have petition to be introduced in the state legislature at each session every year via sponsorship of both House and Senate are partisan driven. Work in progress.

Volunteer OMI First Responder at First Responder - Line of Duty Death & Funerals 1999 - 2014 (15 years)

My standard protocol and procedures is when a line of duty death occurs anywhere in the State of New Mexico, I give up my time to volunteer and respond to OMI and assist the law enforcement agency Honor Guard Unit with whatever they need. If these officers are hungry, I feed them. If they are thirsty, I bring them something to drink. If they just need some emotional peer support, I give it to them. This police chaplain service is one of a kind in the State of New Mexico. The important purpose and objective for responding to OMI during this type of tragedies is to ensure the deceased police officer human remains regardless of what law enforcement department they are assigned on their last watch is never left alone 24/7. As part of this volunteer Honor Guard Duty assignment, I want to ensure their grieving families are totally supported throughout the line of duty funeral services and afterwards. It is a long time commitment and I am honored to serve my God in this capacity. Many people ask me why I don't get paid to do this type of work and my response is: "The authority is my God who calls me to serve and vest in Him and He does not want payment."
