### **Background and Summary:**

On March 14, 2015, Santa Fe County received notification from the Governor (Exhibit A) that there was an immediate vacancy in the office of State Senator for New Mexico Senate District 39. The Governor requested that the Board of County Commissioners (Board) submit a nomination to her by 5:00 p.m. on March 15, 2015. In response, the Board held an emergency meeting on Sunday, March 15, 2015, at 12:00 p.m.

At its March 15, 2015, meeting, the Board unanimously voted to:

- 1. Solicit applications from persons interested in being appointed to the vacant senate seat through 5:00 p.m. on Wednesday, March 18, 2015; and
- 2. Hold a special meeting at 10:00 a.m. on Friday, March 20, 2015, to consider the applications for possible recommendation to you pursuant to NMSA 1978, § 2-8D-4(B)(2)(a).

The Board Chair informed the Governor of this in a letter that same day.

The Board also directed staff to develop a simple application that addressed constitutional requirements for holding the office of State Senator and required applicants to submit a letter of interest and resume along with the application.

With this direction, staff developed a simple application form (Exhibit B), which was to be notarized and accompanied by proof of legal residence, proof of citizenship, and proof of age. The call for applicants was posted on the County's web-page along with the application form and background information (Exhibit C).

After a review of the application requirements and telephonic discussions with Mr. Ambrose Castellano, Mr. Castellano withdrew his application.

Due to the short time frame established by the Board, not all applicants were able to submit proof of U.S. Citizenship – e.g., copies of a passport, birth certificate, or consular report of birth abroad or certification of birth. Those that were not able to submit proof of U.S. Citizenship are Nicole Castellano, Brent Racher, Michael A. Vigil, Jose L. Villegas, Sr. Each of these applicants, however, swore under oath that they were U.S. Citizens and submitted what they could to support that sworn statement (e.g., a social security card).

Included within the Board's packets are the application form, letter of interest, and resume for each of the received and complete applications. We did not include supporting documentation concerning proof of legal residency, proof of citizenship, or proof of age. This supporting documentation is available for inspection by Commissioners in the County Manager's Office.

Dear Chairman Anaya,

Due to the resignation of Senator Phil Griego, a vacancy now exists in the Senate for District 39, a district that includes portions of your county. There are only seven days remaining in the 2015 legislative session. It is imperative that the citizens of District 39 maintain representation through the rest of the legislative session.

I am requesting that the County Commission invoke its emergency meeting provisions for the purpose of submitting a nomination to fill the vacancy. If an appointment is not made before the Senate reconvenes on Monday morning, all residents of Senate District 39 will be unrepresented and your voters will be disenfranchised. This is a serious issue affecting core constitutional rights of New Mexico residents.

Thank you for your prompt attention to this critical issue.



The Board of County Commissioners (BCC) of Santa Fe County is accepting applications from individuals interested in representing State Senate District 39. The senate seat is vacant following the recent resignation of former Senator Phil Griego.

Interested persons must submit (i) a one-page application and supporting documentation concerning constitutional requirements for holding this office; (ii) a letter of interest explaining their interest and qualifications for the position; and (iii) a resume. The one page application must be notarized.
