Summary:

Resolution No. 2018-____, A Resolution Adopting the Transportation Advisory Committee 2018 Work Plan and Meeting Schedule will approve the Transportation Advisory Committee (TAC) 2018 TAC Work Plan (see Exhibit A). The TAC met on February 21, 2018 and voted to recommend that the BCC approve the 2018 TAC Work Plan as per the requirements of Resolution 2015-13.

Background and Discussion:

Resolution No. 2015-13 created the TAC which replaced the previous Road Advisory Committee and states that the Committee shall adopt and present to the BCC for approval an annual work plan.

At the Jan. 30, 2018 meeting the BCC made appointments to the TAC and directed staff to prepare and present a draft 2018 Work Plan at the first TAC Meeting. The TAC held the committee's first meeting on February 21, 2018. Staff presented the draft 2018 Work Plan and discussed the plan with the committee members. TAC voted to recommend that the BCC approve the work plan (see Exhibit B).

Task outlined in the Work Plan include:

- 1) Road Acceptance Proposals: Review Road Acceptance applications as appropriate in accordance with approved County policies; make recommendations to the BCC on privately owned, developed and maintained roads that are being proposed for the County to accept, own and maintain as part of the County Road system.
- 2) Santa Fe County Transportation Plan: Review draft Santa Fe County Transportation Plan. Provide comment, feedback, and make recommendations to the BCC regarding plan adoption.

The proposed 2018 TAC Work Plan can be amended as needed to include additional tasks as directed by the BCC. The TAC is scheduled to meet quarterly and additional meetings may be scheduled as needed (see Exhibit B).
