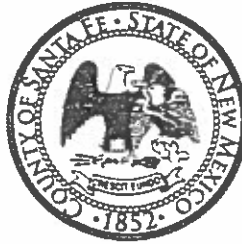

### **Issue:**

The Community Services Department is submitting recommendations to the Board of County Commissioners to appoint a Trustee at the Stanley Cyclone Center.

### **Background:**

Santa Fe County Resolution 2013-61, Exhibit A, Section II states that the Commission shall appoint one or more Trustee(s) at each Community Center to assist the Community Services Department in the operation of the Centers. Other responsibilities of the Trustees include working with the County to schedule, process, and calendar events and take on other responsibilities associated with running the Centers at the request of the Director of the Community Services Department or his/her designee.

Santa Fe County Resolution 2015-24 added the Stanley Cyclone Center as a Community Center. Based on recommendations received, the Community Services Department supports the appointment of Kim Anaya as a Trustee at the Stanley Cyclone Center.

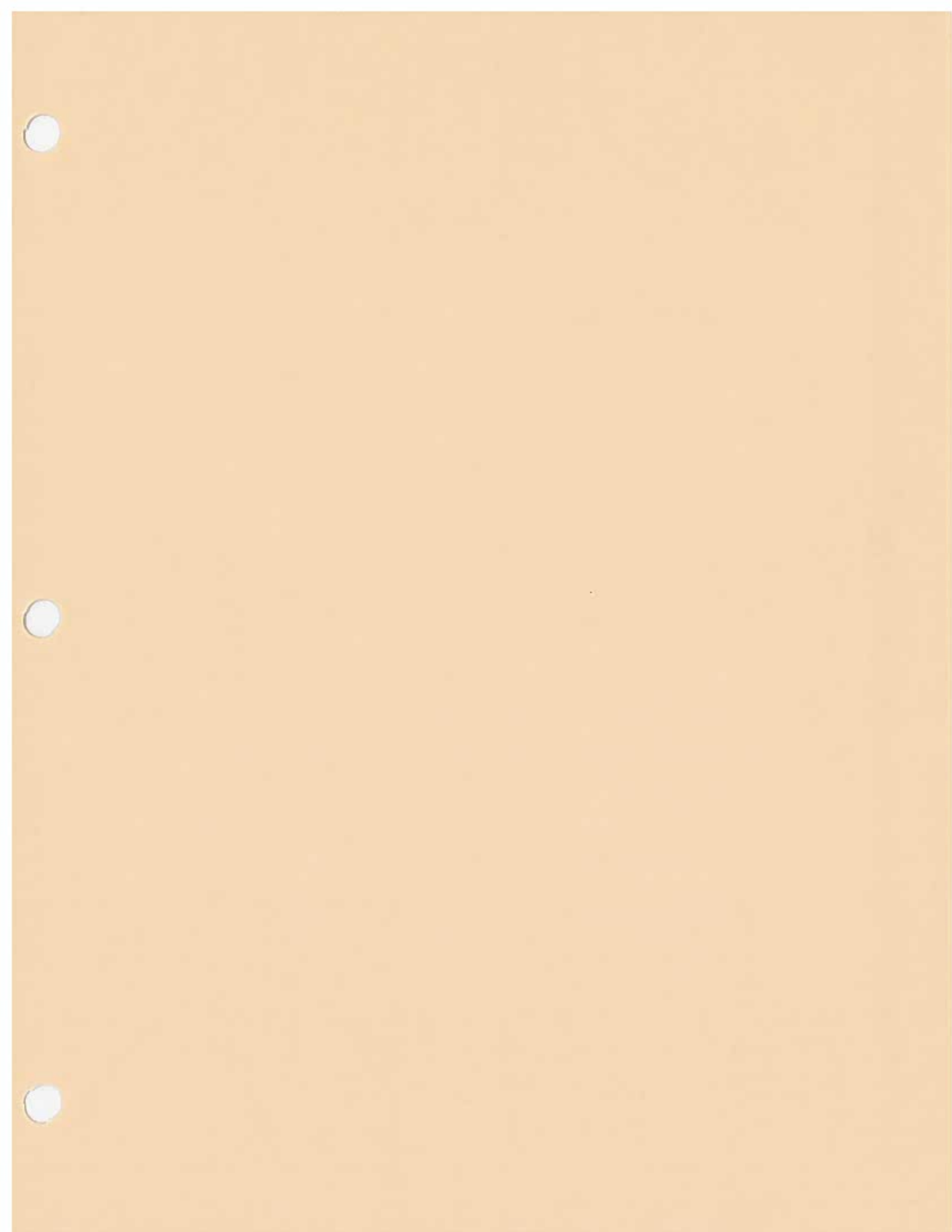
**Staff Recommendations**

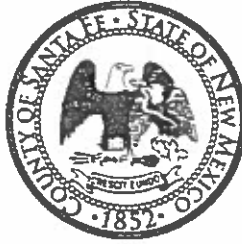

### **Issue:**

The Community Services Department is submitting recommendations to the Board of County Commissioners to appoint members to the County Fair Board.

### **Background:**

Santa Fe County Ordinance No. 2000-5 establishes duties, powers, and procedures of the County Fair Board. The current Ordinance allows for no less than nine (9) members and no more than thirteen (13) members to serve on the County Fair Board. There are currently four members whose terms were to expire December 31, 2014. They were:

Mike Dobesh made the decision not to pursue another term with the Fair Board. In addition, Shawn Thompson (District 3), whose term did not expire until December 31, 2015, submitted his verbal resignation to the Fair Board at the meeting on October 14, 2014.

**Fair Board Recommendation:**

Per the current Ordinance, the Chair of the County Commission can name members to fill vacancies of members who have resigned or can no longer serve on the board. Recommended to fill these vacancies were:

Basil Davis	District 3 (Shawn Thompson vacancy / term through 12/31/15)

At the January 27, 2015 Board of County Commission Meeting, all of the above were appointed with the exception of Karen Paige. Commissioner Roybal requested a meeting with Ms. Paige that occurred in February and at the March 31, 2015 BCC meeting, Ms. Paige was appointed.

At the January 27, 2015 Board of County Commission Meeting, it was also requested to have someone represent District 4 on the Board. The person that is interested in representing District 4 is Karolyn Wilson. Commissioner Holian has approved bringing her name to the BCC for appointment.

**Staff Recommendations**

The Community Services Department recommends that Karolyn Wilson be approved to serve which will bring the number of County Fair Board Members to twelve.
