#### **ISSUE:**

The reappointment of Vivien Heye to the Health Policy and Planning Commission (HPPC).

#### **BACKGROUND:**

The resolution establishing membership on the HPPC provides for 13 members, two from each of the five districts, one appointed by the Mayor of the City of Santa Fe, and two Countywide appointments. There are currently vacancies in District 1, District 2, and District 5. During the month of March, these HPPC openings were advertised in the Santa Fe New Mexican and the Albuquerque Journal, a press release went out, the vacancies were posted on the County website, and outreach was done through email distribution. Vivien Heye was the only applicant within District 2, and we recommend her reappointment.

#### **RECOMMENDATION:**

We recommend the reappointment of Vivien Heye to one of the District 2 positions on the HPPC. Vivien Heye has a background in rehabilitation counseling and has worked with the developmentally disabled and people with HIV/AIDS, and now does volunteer work in harm reduction and opioid overdose prevention. Since her initial appointment to the HPPC, Ms. Heye has served on the Santa Fe Opiate Safe working group and is helping to track the work on reducing drug abuse, which is one of the key priorities in the County Health Action Plan. Her reappointment will provide valuable continuity to the work of the HPPC.

Dear Commissioner Chavez and Commission Members:

I have lived in New Mexico for forty-seven years (47) years. I came to UNM to do a Masters in Counseling, moved to Santa Fe, and stayed. Over the years, I have seen many changes and have worked for many changes in the systems which affect our lives and the lives of our children.

I did vocational rehabilitation counseling for ten years, learning much about the conditions and disabilities which affect our Santa Fe citizens. For one year I worked specifically with Developmentally Disabled and learned much about the systems which support our fellow citizens, and especially family and caregivers. I then became involved with people with AIDS and HIV, as well as people who inject drugs. I also worked with the Public Education Department trying to champion behavioral health initiatives, and, finally, with the Epidemiology Division in the Department of Health.

This broad experience has helped me to both understand broader perspectives of community health and the necessary details of programs which contribute to improving the challenges which we face in our community's overall health.

This is why I am seeking to contribute to the Health Policy and Planning Commission's mission and goals. Most recently, I have been a volunteer with two non-profit organizations which provide services to heroin/opiate users. The people who are served are among the most compromised in our population. Poverty, cultural alienation, and historic cultural trauma have been cited as causes for the addiction problems we see. Whatever the cause, we need to seek solutions which are culturally based and relevant to the populations which we are dedicated to serve.

Since January, 2012, I have volunteered with Santa Fe Community Services which serves the homeless population in Santa Fe. My specific tasks have been to provide syringe exchange, training on Narcan for opioid overdose prevention, and auricular acupuncture, commonly known as Acudetox, which assists people with addictions to overcome cravings and make better decisions about their health. I also do this volunteer work with Santa Fe Mountain Center in northern Santa Fe County. This volunteer experience, working with the people we are serving,

has certainly expanded my knowledge and experience on more than just an intellectual and epidemiological basis. I have first-hand experience with people in need.

I have been active in working on the current HPPC Action Plan, on Priority #3, Reduce Drug Abuse. I have worked with the HPPC Chairperson, Health and Human Services staff, and other commissioners to develop the indicator and evaluation baselines. I have also attended HPPC's community partner on this priority, the Santa Fe Opiate Safe group (SOS) meetings, during my current term to support their efforts to reduce drug abuse in Santa Fe county. I would like to continue to work on the HPPC Action Plan.

House Memorial 26 has been introduced in the current legislative session and calls for a task force to develop a statewide strategic plan to address Hepatitis C, which is closely correlated with injection drug use. Santa Fe County Health Policy and Planning Commission is one of the designated representatives to participate in the task force and I would very much like to continue on the HPPC to be able to participate in this task force.



#### **ISSUE:**

The appointment of Kim Straus to the Health Policy and Planning Commission (HPPC).

#### **BACKGROUND:**

The resolution establishing membership on the HPPC provides for 13 members, two from each of the five districts, one appointed by the Mayor of the City of Santa Fe, and two Countywide appointments. 

#### **Background**

The Santa Fe City - County Advisory Council on Food Policy (Council) was established by the City and County by Resolutions of the governing bodies in 2008. Resolution 2008-5 establishes the Council membership as thirteen members, which consists of two employees from the City of Santa Fe and Santa Fe County respectively, and nine members from the public sector, of which, four are appointed by the Board of County Commission (Board).

#### Issue

In March of 2015, the Council had a County appointed member resign and the Board directed staff to solicit for a replacement member. As a result of the advertisement and call for interested public members, the County received one application from Ms. Maria De Anda Hay.

Ms. De Anda Hay previously served on the Santa Fe County Development Review Committee and is familiar with County policies including the Sustainable Growth Management Plan, and has a particular interest in agricultural land use and mechanisms to promote the preservation and protection of agricultural land and resources in order to sustain the production of locally grown and produced food products.

Ms De Anda Hay has also worked in the local food industry by promoting locally produced food products through her own business, and is passionate about promoting agricultural economic opportunities and education and training for the next generation of farmers.

#### Recommendation

The Board appoints Ms. Maria De Anda Hay to serve on the Santa Fe City - County Advisory Council on Food Policy to serve the remainder of the vacant term which will expire in January 2016.

Representation from related state, federal and local governments should be encouraged including: (but not limited to) the women, infants and children (WIC) Program administered by the New Mexico Department of Health, the food stamp program administered by the Income Support Division of the New Mexico Human Services Department, the county extension office administered by the New Mexico Department of Agriculture and the Santa Fe School District.
- 5. The Council shall elect a chairperson and vice chairperson. The chairperson may appoint sub-committees and sub-committee chairpersons as needed. Subcommittees may also include non-Council members from the public or private sectors. The Council may request representatives from those government agencies listed in paragraph 4. above as appropriate for subcommittees.
- E. <u>TERMS.</u> Of the initial appointments, six of the members shall be appointed for two year terms and seven shall be appointed for three year terms. Subsequent terms shall be for three years to maintain staggering of terms. There shall be no limitation to the number

of consecutive terms a member may serve. The chairperson shall serve for a two year term. After three consecutive unexcused absences a Council member shall be automatically removed and notified thereof by the chairperson. Vacancies shall be filled in the same manner as initial appointments and shall be for the remainder of the unexpired term. Members may be removed by the Mayor with the approval of the City Council or by the Board of County Commissioners as originally appointed, with or without cause.

- F. MEETINGS. A quorum shall be at least seven members. The Council will meet as needed and shall conduct all meetings in accordance with the New Mexico Open Meetings Act and adopted City and County policies and procedures.
- G. STAFF. The County health and human services department will serve as the primary liaison to the Council and the City will provide stenographic services; however, the City and County Managers may agree to rotate, on an annual basis, the primary liaison and stenographic services responsibilities. Depending upon the issue, other City or County staff may also be required to assist the Council. The Council may also use donated assistance from the state or federal governments or the private sector. The Council may request assistance from all departments in the City and County in the performance of its duties in order that the established food policies of the City and the County may be realized.



## **BACKGROUND**

On May 31, 2011, the Santa Fe County Board of County Commissioners approved Resolution 2011-80, a resolution to establish the Santa Fe County Audit Committee and to define its purpose, functions, membership, structure and other requirements. The Audit Committee has three (3) core functions listed below:

- 1. to ensure that County management is maintaining a comprehensive framework of internal control, and the established framework is adequate to protect the assets of Santa Fe County;
- to ensure that the financial statements are properly audited and that any problems therein are disclosed and properly resolved; and
- 3. to oversee and review the internal audit function of the County as applicable.

Resolution 2011-80 establishes the membership requirements of a three (3) member committee as a staff representative from the County's Finance Division and a staff representative from the County's Legal Division, both appointed by the BCC. The third member is appointed by the County Manager. The Resolution also establishes terms of service for each of the members. The Finance Division member shall serve an initial two (2) year term and may be appointed for one subsequent term of two (2) years. The Legal Division member shall serve an initial term of one (1) year and may be appointed to serve on subsequent two (2) year term.

At its inception, the Finance Director Teresa Martinez served as the Finance Division staff representative and Deputy County Attorney Rachel Brown served as the Legal Division staff representative. Since that time, Committee Member Martinez has retired from the County and thus, can no longer serve as the Finance Division staff representative. The term of Committee Member Brown has expired and appointment of a new staff representative from the Legal Division is


needed. The third member who was appointed by the County Manager, Don Dayton, has resigned from the Committee. As a result, the Audit Committee currently has no members.

## **ISSUE**

In order to ensure that the functions of the Audit Committee can resume, it is necessary for staff representatives from the Finance Division and the Legal Division to be appointed by the BCC. The Finance Division is recommending the appointment of Finance Division Director Carole Jaramillo to serve a two (2) year term and County Attorney Gregory Shaffer to serve a one (1) year term, each with the possibility of serving a subsequent two (2) year term as is authorized in Resolution 2011-80. The third member will be appointed by the County Manager to serve a two (2) year term as provided in the Resolution with the possibility of serving a subsequent two (2) year term.

#### **SUMMARY**

The Finance Division is requesting the appointment of Carole Jaramillo to serve as the Finance Division representative and Gregory Shaffer to serve as the Legal Division representative on the Audit Committee for an initial two (2) year term and one (1) year term respectively.
