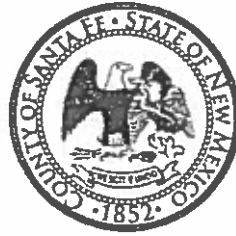

SUBJECT: Recognition of Fire Marshal Buster Patty on his retirement from the Santa Fe County Fire Department (Fire Department/Fire Chief Sperling).

BACKGROUND:

Fire Marshal Buster Patty has announced his retirement from Santa Fe County Fire Department effective June 1, 2016.

FM Patty has been a valued member of the Fire Service for 34 years, including 20 years with Santa Fe County. He began his career in 1979 as the Fire Chief of the Glorieta Conference Center in eastern Santa Fe County. He served the Conference Center until 1988 before he was hired in 1990 by Wendy Beck as the first Santa Fe County Fire Prevention Officer and a County Fire Investigator.

FM Patty left Santa Fe County in 1996 and moved to Clear Lake, Texas. While working in Texas, FM Patty continued his interest in the fire service by volunteering on a Fire Boat. In 2001, he returned to Santa Fe, and under the guidance and encouragement of former Fire Chief Stan Holden, he rejoined the Fire Department Prevention Division. His skill and knowledge earned him promotions to Fire Prevention Captain, Acting Fire Marshal, and Santa Fe County Fire Marshal in 2011.

FM Patty is recognized throughout Santa Fe County for his extensive knowledge and skill in fire prevention. His understanding of fire codes and standards and their implementation is second to none. His approach has always been to implement the fire code in a fair and consistent manner, while simultaneously working with customers to build their understanding of the code requirements and how they protect lives and property. FM Patty has always done his job with dedication to the principles of prevention, and with kindness and compassion for his many diverse customers. He has been an outstanding Fire Marshal for Santa Fe County and will be greatly missed.

The Fire Department requests the support of the Board of County Commissioners in recognizing and honoring the accomplishments and service of Fire Marshall Buster Patty upon his retirement from the Santa Fe County Fire Department, and wishing him the best in the future.
