For the month of June 2017, the following employees will be recognized:

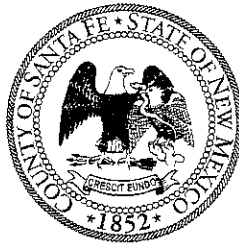
