





This resolution will adjust the budget for Thornton Ranch Open Space capital project due to an error that was made when clean-up/realignment of the FY 16 capital budget was made.


BACKGROUND:

In September 2015 the Board of County Commission approved Resolution 2015-132 to realign capital project budgets for FY 16 to the FY 15 ending balances for various capital projects. At that time an error was made and the Thornton Ranch Open Space project was decreased by too much.

The attached Budget Adjustment will correct the budget for the Thornton Ranch Open Space project by budgeting cash carryover to ensure that the project's budget equals the allocation amount that was approved for the project.

<u>RECOMMENDATION:</u>

The Finance Division recommends that the budget for Thornton Ranch Open Space project be increased by \$55,047 to correct the budgeted amount and ensure that the budget balance equals the allocation amount.
