ISSUE

On June 10, 2014, the Board of County Commissioners approved Resolution 2014-45, a resolution adopting an Accounts Receivable Allowance for Doubtful Accounts and Write-Off Policy and Procedures. The policy establishes a process by which accounts deemed uncollectible can be removed from the County's accounts receivable listing creating a more accurate detail of accounts receivable.

BACKGROUND:

The Santa Fe County Finance Division, in compliance with Resolution 2014-45, has adopted procedures to write-off uncollectible debt. The Finance Division has compiled a listing of accounts proposed to be written off in the attached schedule. The accounts in the attached schedule are the result of billings for services related to the housing of inmates based on terms and conditions of the County. The following efforts were made to collect the accounts: bills were sent to the entities and attempts to contact entities by telephone were made. As availability allowed, conversations were held with entities regarding the accounts and all appropriate attempts to resolve outstanding receivables have been made. The accounts have been delinquent more than four years and in the Finance Director's opinion they are uncollectible accounts. In accordance with Resolution 2014-45, the Finance Division is proposing accounts in the attached schedule to be written off. The period of write-off is from July of 2011 to June of 2012.

RECOMMENDATION:

The Finance Division is requesting approval of the Resolution to Write-Off Uncollectible Accounts for the Santa Fe County Adult Detention Facility, effective as of the date of approval.



ISSUE

The County Manager's Office and Finance Division are seeking approval of a resolution to commit fund balance for the purpose of setting aside funds for the reserves identified in the Santa Fe County Fund Balance, Reserve and Budget Contingencies Policy.

BACKGROUND

At its June 9, 2015 meeting the Board of County Commissioners passed Resolution 2015-84 adopting the Santa Fe County Fund Balance, Reserve and Budget Contingencies Policy. This policy provides a process for committing unrestricted fund balance to set aside funds for specific purposes. The Policy states: "Funds shall be set aside as a Committed Fund Balance by passage of a resolution or ordinance."

Further, the policy establishes minimum reserves that the County shall maintain in the General Fund, Special Revenue Funds which support on-going operations, and Enterprise Funds. Within the General Fund, minimum reserve requirements specifically include creation of a contingency reserve equal to 10% of the general fund budget, a disaster recovery reserve equal to 10%-15% of the unassigned fund balance from the prior year Comprehensive Annual Finance Report (CAFR), an uninsured loss reserve equal to 5% - 10% of the unassigned fund balance from the prior year CAFR, and a major infrastructure repair and replacement reserve equal to 10% - 15% of the unassigned fund balance from the prior year CAFR.

Further, in any special revenue fund or enterprise fund (excluding utilities) that supports staff and/or ongoing operations a minimum reserve requirement of 10% of the budget for that fund (excluding

grants or funds supported by non-recurring sources) is required. Finally, the Utilities enterprise fund has a minimum reserve requirement of 50% of the operating budget.

For those reserve requirements that identify a percentage range of the unassigned fund balance from the prior year CAFR, the recommended amount to be committed was determined based upon budget decisions made by the BCC in the final FY 2017 budget as presented.

SUMMARY

The County Manager's Office and Finance Division are requesting that the Board of County Commissioners pass this resolution to commit fund balance for the purpose of setting aside funds for the reserves identified in the Santa Fe County Fund Balance, Reserve and Budget Contingencies Policy.





ISSUE

The Finance Division is seeking approval of a resolution clarifying the use of the health care assistance funds to affirmatively allow for use of the funds by indigent patients and persons residing at the Adult Detention Facility and the Youth Development Program.

BACKGROUND

The Board of County Commissioners approved Resolution 2014-47 which established the Santa Fe County Health Care Assistance Program funded from the second one-eighth increment gross receipts tax. The resolution states "Santa Fe County's Health Care Assistance Program shall provide health care services for indigent patients domiciled in the County, and shall support the health priorities set forth in the Santa Fe County Health Action Plan FY 2015-2017." The resolution goes on to state that the funds may be used to pay for eligible claims and support initiative and projects to provide services to indigent patients targeted to the priorities in the health action plan.

Health services provided to indigent patients and persons who are residing at one of the County's detention facilities were not specifically addressed in Resolution 2014-47. The proposed resolution will allow for the use of Health Care Assistance Program funds to provide health services to that specific population, and authorizes the County Finance Director to budget and expend funds for that purpose.

RECOMMENDATION

The Finance Division recommends approval of the resolution to authorize budgeting and expenditure of the Santa Fe County Health Care Assistance Fund for indigent patients and persons residing at Santa Fe County's detention facilities.

WHEREAS, the Indigent Hospital and County Health Care Act ("Act"), NMSA 1978, Sections 27-5-2 et seq. (1965, as amended through 2014), recognizes among other things "that each individual county of this state is the responsible agency for ambulance transportation, hospital care or the provision of health care to indigent patients domiciled in that county, as determined by resolution of the board of county commissioners"; and

WHEREAS, the Santa Fe County Health Care Assistance Fund ("Fund") has been established pursuant to Section 27-5-7 of the Act; and

WHEREAS, under Section 27-5-7.1 of the Act, the Fund may be used to pay expenses associated with the "burial or cremation of an indigent person," "ambulance transportation, hospital care and health care services for indigent patients," and "county administrative expenses associated with [the forgoing] fund expenditures ..."; and

WHEREAS, pursuant to the Act, the Board of County Commissioners ("Board") for Santa Fe County ("County") passed Resolution No. 2014-47 expressly authorizing and limiting how the County will budget and expend the Fund; and

WHEREAS, pursuant to Resolution No. 2014-47, the Board passed Resolution No. 2015-82 adopting Procedures for Processing Eligible Provider Claims Under the Indigent Hospital and County Healthcare Act; and

WHEREAS, under Resolution No. 2014-47, the Board did not authorize expenditures from the Fund to the full extent permitted under the Act; and

WHEREAS, the County incurs substantial and increasing costs in providing health care and related services to indigent persons and patients residing in the County's detention facilities; and

WHEREAS, to partially offset the forgoing costs, the Board now desires to expressly authorize the budgeting and expenditure of the Fund to the full extent permitted


under the Act to pay for services rendered to indigent persons and patients residing at the County's detention facilities.



ISSUE

The Finance Division is requesting approval of the FY 2017 Final Budget.

BACKGROUND

On May 31, 2016 the Board of County Commissioners approved the FY 2017 Interim budget. The FY 2017 Interim budget was developed based upon recommendations presented during the May 10, 2016 planning session which included staff compensation, new FTE's, fixed asset renewal and replacement, expanded programming, and development of funding pools for various needs. The Finance Division has completed preparation of the FY 2017 Final Budget which includes changes from the approved FY 2017 Interim budget. Changes are:

- Adjustments to salary and benefits to reflect new hires, separations, promotions and salary adjustments which have taken place since the Interim Budget was approved.
- Adjustments to project carry over amounts.
- Adjustments to grant carry over amounts.
- Adjustments to interfund transfer amounts as necessitated by the above changes.

The proposed Santa Fe County fiscal year 2017 budget for which we are seeking approval totals \$338.6 million across 49 separate funds. The proposed budget includes:

• For non-union staff, a 1% COLA to be effective the first full pay period after 1/1/17, an equivalent amount for bargaining unit economic re-openers, and the IAFF contract proposal was built into base. Compensation packages total \$317K.

- One new full-time FTE and 10 temporary FTEs totaling \$193K net of offsetting reduction in contract services. Other HUG recommended requests will be re-evaluated after the first quarter and at mid-year of FY2017.
- Expanded programming (recurring and one-time) totaling \$3.2 million.
- Other increases to the base budget totaling \$1.0 million.
- Funding pools for energy programs, Local Economic Development Act (LEDA) projects and health insurance reserve set-aside totaling \$3.5 million.
- Fixed asset renewal and replacement maximum funding (including VURB recommendations) of \$4.9 million across all funds.
- Capital and large maintenance projects totaling \$78.6.

Also included in the proposed budget is debt service totaling \$54.3 million, of which \$35.5 million is payment the Series 2007A and Series 2007B general obligation bonds which were advance refunded last fiscal year and for which we have proceeds from that refunding bond issuance held in escrow. Finally, interfund transfers that are "double counted" totaling \$57.6 million are included in the budget.

SUMMARY

The Finance Division is requesting approval of the resolution adopting the FY 2017 Final Budget.





BACKGROUND:

On March 28, 2006, Resolution No. 2006-53 was adopted which authorized certain County staff to issue citations of violations of County Ordinances.

On June 25, 2013, Resolution No. 2013-62 was adopted, repealing and replacing Resolution No. 2006-53, to authorize certain Growth Management staff and the Enforcement Officer for the Solid Waste Division to issue citations for violations of County Ordinances.

On November 27, 2013, Resolution No. 2013-128 was adopted, amending Resolution No. 2013-62, to authorize an additional Code Enforcement Officer (Daniel Diaz) to the list of those authorized to issue citations for violations of County Ordinances.

SUMMARY:

On January 11, 2016, the Building and Development Services Department hired a new Code Enforcement Officer to issue citations of County Ordinances. This proposed resolution includes the newly hired Code Enforcement Officer and an additional staff member. To simplify the process of reviewing and applying this Resolution, we request the BCC repeal Resolutions 2006-53, 2013-62, and 2013-128, so the substance of the Resolution is one single document rather than in three separate Resolutions.

STAFF RECOMMENDATION:

Staff recommends adoption of this resolution, memorializing the individuals who may enforce the Ordinances and Code of Santa Fe County in one single document.


