

RE: **A Presentation on the Greater Santa Fe Fireshed Coalition and the Implementation, Resilience Strategy, and Communication Teams By Eytan Krasilovsky, Southwest Director, Forest Stewards Guild. Also Included is a Review of Current Community Perspectives, Opportunities to Support Fire Adapted Communities, and Actions for the BCC (Commissioner Holian)**

Issue:

On the June 28th agenda, under Proclamations and Presentations:

A Presentation updating the Santa Fe County Board of County Commissioners on the progress of the Greater Santa Fe Fireshed Coalition, of which the County Fire Department is part of.

- The Greater Santa Fe Fireshed Coalition began in early 2015 as a grant proposal by the Forest Stewards Guild to the Rio Grande Water Fund to expand forest treatments from the City Municipal Watershed to adjacent areas to the north and south and was initially focused on completing National Environmental Policy Act compliance on federal lands. Then at the end of 2015, under leadership from the State Forester, the Mayor of Santa Fe, and the City of Santa Fe Fire Chief, the project the was reborn as a larger collaborative effort for a priority landscape within the Rio Grande Water Fund. In less than eight months there are now complementary County and City resolutions and many other accomplishments.
- Eytan will also update the BCC on the variety of community perspectives on the management of forests in the Fireshed, how the BCC can support fire adapted communities, and opportunities to support the Santa Fe National Forest .



PROCLAIMING THE MONTH OF JUNE 2016 AS
NATIONAL SAFETY MONTH
IN CONJUNCTION WITH THE NATIONAL SAFETY COUNCIL

WHEREAS, all Santa Fe County Citizens deserve to live in communities that promote safe and healthy living environments; and safe communities require the cooperation of all levels of government, business, and industry employees, as well as the general public; and

WHEREAS, through the support and observance of National Safety Month, each year employers are helping to reverse an increase in accidental injuries and deaths in the workplace; and

WHEREAS, Santa Fe County works to prevent accidental injuries and deaths by educating employees about safe and health practices in the workplace, on our roads and highways, and in our homes and communities; and

WHEREAS, citizens are encouraged to share stories with their community about the importance of safety at work and at home including: distracted driving awareness, hazard avoidance, emergency preparedness, and preventing the abuse of prescription painkillers or other substances; and

WHEREAS, the beginning of the summer season, traditionally a time of increased accidental injuries and fatalities, is an appropriate time to focus attention on injury risks and preventions.

NOW THEREFORE, BE IT PROCLAIMED by the Board of County Commissioners of Santa Fe County that the month of June 2016 is:
