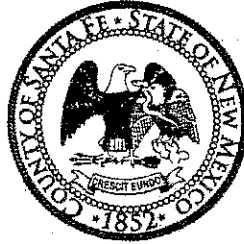

ITEM AND ISSUE: BCC Meeting July 10, 2018

Request Ratification of the County Manager's Signature Approval of the HIDTA Grant No. G18SN0011A Modification in the Amount of \$112,005.00 for a Total Grant Award of \$320,013.00, and the Application for Federal Assistance SF-424, Through the Southwest Border HIDTA New Mexico Region III Taskforce, Effective from January 1, 2018 Through December 31, 2019. (Bill Taylor, Purchasing Division)

SUMMARY:

The HIDTA Award No. G18SN0011A in the amount of \$208,008.00 is being amended (supplemental) in the amount of \$112,005.00 resulting in a total award of \$320,013.00.

This packet contains three documents for signature by the County:

Grant Agreement showing the \$112,005.00 supplemental award;

Grant Award showing the total grant award of \$320,013.00;

Application for Federal Assistance SF-424-the application for the total grant amount of \$320,013.00.

The County Manager was authorized under paragraph 3(b) of Ordinance 2014-143 to sign the original Grant Agreement for the amount of \$208,008.00; however the Manager is not authorized to approve and sign the supplement Grant Award for \$112,005.00 and the Application for Federal Assistance SF-424, because it raises the total grant sum over the \$250,000 threshold for County Manager approval.

Due to the time limits on the County's acceptance of the supplement and the grant terms and conditions, the Manager may approve and sign all three documents and then have her approval and signature later ratified by the BCC.

BACKGROUND:


The High Intensity Drug Trafficking Areas (HIDTA) Program supports initiatives designed to implement the Strategy proposed by the Executive Board of the SWB – New Mexico HIDTA and approved by the Office of National Drug Control Policy (ONDCP). The funding provided through HIDTA-New Mexico Region III is to assist law enforcement agencies for the investigative costs associated with overtime, travel, supplies and other investigative services and operations in combating drug trafficking in the State. These funds are to subsidize the operations of the Region III office here in northern New Mexico.

ACTION REQUESTED:

BCC ratification of the County Manager's signature of Grant Award No. G18SN0011A Modification in the amount of \$112,005.00, for a total Grant Award Sum of \$320,013.00, and the Grant Application for Federal Assistance.

HITDA Award # G185N0011A in the amount of \$208,008.00 is being amended (supplemented) in the amount of \$112,005 resulting in a total award of \$320,013.00. According to Santa Fe County Ordinance No. 2014-143 3(b) (Grant Agreements), the County Manager is authorized to approve and sign an amendment to a grant for which the original grant agreement was signed by the Manager. According to 3(b) the County Manager is not authorized to sign a grant application that would commit the County to accept a grant the amount of which is beyond the signature authority of the County Manager. According to 3(b) the County Manager is not authorized to approve and sign a grant agreement that is more than \$250,000.

This packet contains three documents for signature by the County: The **Grant Agreement** showing the \$112,005 supplemental award; a **Grant Award** showing the total grant award of \$320,013; and an **Application for Federal Assistance SF-424** that is an application for the total grant in the amount of \$320,013.

The Manager is authorized under 3(b) of Ordinance 2014-143 to sign the Grant Agreement for the \$112,005 supplement, however, the Manager is not authorized to approve and sign the Grant Award for the total sum of \$320,013 and the Application for Federal Assistance SF-424 that shows HITDA Award # G185N0011A in the amount of \$320,013.

These three documents are approved as to form, however, absent a delegation from the Board of County Commissioners (BCC) specifically delegating to the Manager the authority to approve and sign a grant application that is over \$250,000, the Manager is not authorized by Ordinance 2014-143 3(b) to sign the Grant Award in the amount of \$320,013 and the Application for Federal Assistance SF-424 in the amount of \$320,013. According to 3(b), the BCC is authorized to approve and sign on behalf of the County a grant agreement, an amendment to a grant agreement, and grant application that is more than \$250,000.

Due to the time limits on the County's acceptance of the supplement and the grant terms and conditions, the Manager may approve and sign all three documents and then have her approval and signature later ratified by the BCC.

GRANT CONDITIONS

A. General Terms and Conditions

1. This award is subject to The Uniform Administrative Requirements, Cost Principles, and Audit Requirements in 2 C.F.R. Part 200 (the "Part 200 Uniform Requirements"), as adopted and implemented by the Office of National Drug Control Policy (ONDCP) in 2 C.F.R. Part 3603. For this award, the Part 200 Uniform Requirements supersede, among other things, the provisions of 28 C.F.R. Parts 66 and 70, as well as those of 2 C.F.R. Parts 215, 220, 225, and 230.

3. Audits conducted pursuant to 2 CFR Part 200, Subpart F, "Audit Requirements" must be submitted no later than nine months after the close of the grantee's audited fiscal year to the Federal Audit Clearinghouse at <https://harvester.census.gov/facweb/>.
4. Grantees are required to submit Federal Financial Reports (FFR) to the Department of Health and Human Services, Division of Payment Management (HHS/DPM). Federal Financial Report is required to be submitted quarterly and within 90 days after the grant is closed out.

7. Conflict of Interest and Mandatory Disclosures

A. Conflict of Interest Requirements

As a non-Federal entity, you must follow ONDCP's conflict of interest policies for Federal awards. Recipients must disclose in writing any potential conflict of interest to an ONDCP Program Officer; recipients that are pass-through entities must require disclosure from subrecipients or contractors. This disclosure must take place immediately whether you are an applicant or have an active ONDCP award.

Organizational conflicts of interest means that because of relationships with a parent company, affiliate, or subsidiary organization, you are unable or appear to be unable to be impartial in conducting a sub-award or procurement action involving a related organization.

B. Mandatory Disclosure Requirement

As a non-Federal entity, you must disclose, in a timely manner, in writing to ONDCP all violations of Federal criminal law involving fraud, bribery or gratuity violations potentially affecting the Federal award. Non-Federal entities that have received a Federal award that includes the term and condition outlined in 200 CFR Part 200, Appendix XII "Award Term and Condition for Recipient Integrity and Performance Matters," are required to report certain civil, criminal, or administrative proceedings to System for Award Management (SAM). 8. Federal Funding Accountability and Transparency (FFATA) / Digital Accountability and Transparency Act (DATA Act). 9. Subawards are authorized under this grant award. Subawards must be monitored by the award recipient as outlined in 2 CFR 200.331.

10. Recipients must comply with the Government-wide Suspension and Debarment provision set forth at 2 CFR Part 180, dealing with all sub-awards and contracts issued under the grant.
11. As specified in the HIDTA Program Policy and Budget Guidance, recipient must:
 - a) Establish and maintain effective internal controls over the Federal award that provides reasonable assurance that Federal award funds are managed in compliance with Federal statutes, regulations and award terms and conditions. B. Recipient Integrity and Performance Matters

Reporting of Matters Related to Recipient Integrity and Performance

1. General Reporting Requirement

 - (ii) It had a different disposition arrived at by consent or compromise with an acknowledgment of fault on your part; and
 - (iii) The requirement in this award term and condition to disclose information about the proceeding does not conflict with applicable laws and regulations.

3. Reporting Procedures

Enter in the SAM Entity Management area the information that SAM requires about each proceeding described in paragraph 2 of this award term and condition. 4. Reporting Frequency

For purposes of this award term and condition:

- a. Administrative proceeding means a non-judicial process that is adjudicatory in nature in order to make a determination of fault or liability (e.g., Securities and Exchange Commission Administrative proceedings, Civilian Board of Contract Appeals proceedings, and Armed Services Board of Contract Appeals proceedings). This includes proceedings at the Federal and state level, but only in connection with performance of a Federal contract or grant. It does not include audits, site visits, corrective plans, or inspection of deliverables.
- b. Conviction, for purposes of this award term and condition, means a judgment or conviction of a criminal offense by any court of competent jurisdiction, whether entered upon a verdict or a plea, and includes a conviction entered upon a plea of nolo contendere.
- c. Total value of currently active grants, cooperative agreements, and procurement contracts includes—
 - (1) Only the Federal share of the funding under any Federal award with a recipient cost share or match; and

- (2) The value of all expected funding increments under a Federal award and options, even if not yet exercised.

C. Program Specific Terms and Conditions

The following special conditions are incorporated into each award document.

1. This grant is awarded for above program. Variation from the description of activities approved by ONDCP and/or from the budget attached to this letter must comply with the reprogramming requirements as set forth in ONDCP's HIDTA Program Policy and Budget Guidance (PPBG).
2. This award is subject to the requirements in ONDCP's HIDTA PPBG.
3. No HIDTA funds shall be used to supplant state or local funds that would otherwise be made available for the same purposes.
4. The requirements of 28 CFR Part 23, which pertain to information collection and management of criminal intelligence systems, shall apply to any such systems supported by this award.
5. Special accounting and control procedures must govern the use and handling of HIDTA Program funds for confidential expenditures; i.e., the purchase of information, evidence, and services for undercover operations. Those procedures are described in Section 6 of the HIDTA Program Policy and Budget Guidance.
6. Property acquired with these HIDTA grant funds is to be used for activities of the SWB - New Mexico HIDTA. If your agency acquires property with these funds and then ceases to participate in the HIDTA, this equipment must be made available to the HIDTA's Executive Board for use by other HIDTA participants.
7. All law enforcement entities that receive funds from this grant must report all methamphetamine laboratory seizure data to the National Clandestine Laboratory Database/National Seizure System at the El Paso Intelligence Center.

D. Federal Award Performance Goals

1. All entities that receive funds from this award are responsible for achieving performance goals established in the HIDTA Performance Management Process (PMP) and approved by the HIDTA's Executive Board and ONDCP.
2. All entities that receive funds from this award must report progress in achieving performance goals at least quarterly using the PMP.

See also Section A. 4 regarding Federal Financial Reports.

E. Payment Basis

1. A request for Advance or Reimbursement shall be made using the HHS/DPM system (www.dpm.psc.gov).
2. The grantee, must utilize the object classes specified within the initial grant application each time they submit a disbursement request to ONDCP. Requests for payment in the DPM system will not be approved unless the required disbursements have been entered using the corresponding object class designations. Payments will be made via Electronic Fund Transfer to the award recipient's bank account. The bank must be Federal Deposit Insurance Corporation (FDIC) insured. The account must be interest bearing.

3. Except for interest earned on advances of funds exempt under the Intergovernmental Cooperation Act (31 U.S.C. 6501 et seq.) and the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450), awardees and sub-awardees shall promptly, but at least annually, remit interest earned on advances to HHS/DPM using the remittance instructions provided below.

Remittance Instructions - Remittances must include pertinent information of the payee and nature of payment in the memo area (often referred to as "addenda records" by Financial Institutions) as that will assist in the timely posting of interest earned on Federal funds. 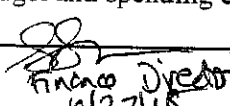
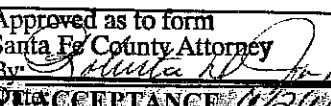
