Request Ratification of the County Manager's Signature Approval of the HIDTA Grant No. G18SN0011A Modification in the Amount of \$112,005.00 for a Total Grant Award of \$320,013.00, and the Application for Federal Assistance SF-424, Through the Southwest Border HIDTA New Mexico Region III Taskforce, Effective from January 1, 2018 Through December 31, 2019. (Bill Taylor, Purchasing Division)

### **SUMMARY:**

The HIDTA Award No. G18SN0011A in the amount of \$208,008.00 is being amended (supplemental) in the amount of \$112,005.00 resulting in a total award of \$320,013.00.

This packet contains three documents for signature by the County:

Grant Agreement showing the \$112,005.00 supplemental award;

Grant Award showing the total grant award of \$320,013.00;

Application for Federal Assistance SF-424-the application for the total grant amount of \$320,013.00.

The County Manager was authorized under paragraph 3(b) of Ordinance 2014-143 to sign the original Grant Agreement for the amount of \$208,008.00; however the Manager is not authorized to approve and sign the supplement Grant Award for \$112,005.00 and the Application for Federal Assistance SF-424, because it raises the total grant sum over the \$250,000 threshold for County Manager approval.

Due to the time limits on the County's acceptance of the supplement and the grant terms and conditions, the Manager may approve and sign all three documents and then have her approval and signature later ratified by the BCC.

### BACKGROUND:

The High Intensity Drug Trafficking Areas (HIDTA) Program supports initiatives designed to implement the Strategy proposed by the Executive Board of the SWB – New Mexico HIDTA and approved by the Office of National Drug Control Policy (ONDCP). The funding provided through HIDTA-New Mexico Region III is to assist law enforcement agencies for the investigative costs associated with overtime, travel, supplies and other investigative services and operations in combating drug trafficking in the State. These funds are to subsidize the operations of the Region III office here in northern New Mexico.

BCC ratification of the County Manager's signature of Grant Award No. G18SN0011A Modification in the amount of \$112,005.00, for a total Grant Award Sum of \$320,013.00, and the Grant Application for Federal Assistance.

HITDA Award # G185N0011A in the amount of \$208,008.00 is being amended (supplemented) in the amount of \$112,005 resulting in a total award of \$320,013.00. According to Santa Fe County Ordinance No. 2014-143 3(b) (Grant Agreements), the County Manager is authorized to approve and sign an amendment to a grant for which the original grant agreement was signed by the Manager. According to 3(b) the County Manager is not authorized to sign a grant application that would commit the County to accept a grant the amount of which is beyond the signature authority of the County Manager. According to 3(b) the County Manager is not authorized to approve and sign a grant agreement that is more than \$250,000.

This packet contains three documents for signature by the County: The **Grant Agreement** showing the \$112,005 supplemental award; a **Grant Award** showing the total grant award of \$320,013; and an **Application for Federal Assistance SF-424** that is an application for the total grant in the amount of \$320,013.

The Manager is authorized under 3(b) of Ordinance 2014-143 to sign the Grant Agreement for the \$112,005 supplement, however, the Manager is not authorized to approve and sign the Grant Award for the total sum of \$320,013 and the Application for Federal Assistance SF-424 that shows HITDA Award # G185N0011A in the amount of \$320,013.

These three documents are approved as to form, however, absent a delegation from the Board of County Commissioners (BCC) specifically delegating to the Manager the authority to approve and sign a grant application that is over \$250,000, the Manager is not authorized by Ordinance 2014-143 3(b) to sign the Grant Award in the amount of \$320,013 and the Application for Federal Assistance SF-424 in the amount of \$320,013. ## A. General Terms and Conditions

Payments will be made via Electronic Fund Transfer to the award recipient's bank account. The bank must be Federal Deposit Insurance Corporation (FDIC) insured. The account must be interest bearing.

3.
