Re: Request Approval Authorizing The County Manager To Sign And Execute a Purchase Order to Purchase Twenty-One (21) Police Interceptors for a Total Sum Amount of \$546,857. (Bill Taylor, Procurement Manager)

ISSUE:

Santa Fe County Resolution 2014-143 established *signature authority of the county manager with respect to certain agreements and applications and ratifying certain intergovernmental agreements previously signed by the county manager based upon apparent authority.*

BACKGROUND:

The Santa Fe Sheriff's Office has capital budget to purchase new vehicles during Fiscal Year 2018. Twenty-one (21) Police Ford Interceptors will be purchased in the sum amount of \$546,857 utilizing the New Mexico Statewide Purchasing Agreement. It has been determined by the County Purchasing Manager that it would be in the best interest of the County and Sheriff's Office that the vehicles be purchased utilizing the New Mexico Statewide Purchasing Agreement.

ACTION REQUESTED:

The Sheriff's Office requests approval authorizing the county manager to sign and execute a purchase order to purchase twenty-one (21) Police Interceptors for a total sum of \$546,857.

Terms and Conditions
(Unless otherwise specified)

1. **General:** When the State Purchasing Agent or his/her designee issues a purchase document in response to the Vendor's bid, a binding contract is created.
2. **Variation in Quantity:** No variation in the quantity of any item called for by this order will be accepted unless such variation has been caused by conditions of loading, shipping, packing or allowances in manufacturing process and then only to the extent, if any, specified in this order.
3. **Assignment:**
 - a. Neither the order, nor any interest therein, nor any claim thereunder, shall be assigned or transferred by the Vendor, except as set forth in Subparagraph 3b or as expressly authorized in writing by the State Purchasing Agent or his/her designee. No such assignment or transfer shall relieve the Vendor from the obligations and liabilities under this order.
 - b. Vendor agrees that any and all claims for overcharge resulting from antitrust violations which are borne by the State as to goods, services, and materials purchased in connection with this bid are hereby assigned to the State.
4. **State Furnished Property:** State furnished property shall be returned to the State upon request in the same condition as received except for ordinary wear, tear and modifications ordered hereunder.
5. **Discounts:** Prompt payment discounts will not be considered in computing the low bid. Discounts for payment within twenty (20) days will be considered after the award of the contract. Discounted time will be computed from the date of receipt of the merchandise invoice, whichever is later.
6. **Inspection:** Final inspection and acceptance will be made at the destination. Supplies rejected at the destination for nonconformance with specifications shall be removed at the Vendor's risk and expense, promptly after notice of rejection.
7. **Inspection of Plant:** The State Purchasing Agent or his/her designee may inspect, at any reasonable time, the part of the Contractor's, or any subcontractor's plant or place of business, which is related to the performance of this contract.
8. **Commercial Warranty:** The Vendor agrees that the supplies or services furnished under this order shall be covered by the most favorable commercial warranties the Vendor gives for such to any customer for such supplies or services. The rights and remedies provided herein shall extend to the State and are in addition to and do not limit any rights afforded to the State by any other clause of this order. **Vendor agrees not to disclaim warranties of fitness for a particular purpose of merchantability.**
9. **Taxes:** The unit price shall exclude all state taxes.
10. **Packing, Shipping and Invoicing:**
 - a. The State's purchasing document number and the Vendor's name, user's name and location shall be shown on each packing and delivery ticket, package, bill of lading and other correspondence in connection with the shipments. The user's count will be accepted by the Vendor as final and conclusive on all shipments not accompanied by a packing ticket.
 - b. The Vendor's invoice shall be submitted duly certified and shall contain the following information: order number, description of supplies or services, quantities, unit price and extended totals. Separate invoices shall be rendered for each and every complete shipment.
 - c. Invoices must be submitted to the using agency and NOT the State Purchasing Agent.
11. **Default:** The State reserves the right to cancel all or any part of this order without cost to the State, if the Vendor fails to meet the provisions of this order and, except as otherwise provided herein, to hold the Vendor liable for any excess cost occasioned by the State due to the Vendor's default. The Vendor shall not be liable for any excess costs if failure to perform the order arises out of causes beyond the control and without the fault or negligence of the Vendor, such causes include but are not restricted to, acts of God or the public enemy, acts of the State or Federal Government,

fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, unusually severe weather and defaults of subcontractors due to any of the above, unless the State shall determine that the supplies or services to be furnished by the subcontractor were obtainable from other sources in sufficient time to permit the Vendor to meet the required delivery scheduled. The rights of the State provided in this paragraph shall not be exclusive and are in addition to any other rights now being provided by law or under this order.

12. Non-Collusion: In signing this bid the Vendor certifies he/she has not, either directly or indirectly, entered into action in restraint of free competitive bidding in connection with this offer submitted to the State Purchasing Agent or his/her designee.

13. Nondiscrimination: Vendor doing business with the State of New Mexico must be in compliance with the Federal Civil Rights Act of 1964 and Title VII of the Act (Rev. 1979) and the Americans with Disabilities Act of 1990 (Public Law 101-336).

14. The Procurement Code: Sections 13-1-28 through 13-1-199 NMSA 1978, imposes civil and criminal penalties for its violation. In addition the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kickbacks.

15. Items: All bid items are to be NEW and of most current production, unless otherwise specified.

16. Payment for Purchases: Except as otherwise agreed to: late payment charges may be assessed against the user state agency in the amount and under the conditions set forth in Section 13-1-158 NMSA 1978.

17. Workers' Compensation: The Contractor agrees to comply with state laws and rules pertaining to Workers' Compensation benefits for its employees. If the Contractor fails to comply with Workers' Compensation Act and applicable rules when required to do so, this Agreement may be terminated by the contracting agency.

18. Submission of Bid: Bids must be submitted in a sealed envelope with the bid number and opening date clearly indicated on the bottom left hand side of the front of the envelope. Failure to label bid envelope will necessitate the premature opening of the bid in order to identify the bid number.

19. Contractor Personnel: Personnel proposed in the Contractor's written bid to the Procuring Agency are considered material to any work performed under this Price Agreement. Once a Purchase Order or contract has been executed, no changes of personnel will be made by the Contractor without prior written consent of the Procuring Agency. Replacement of any Contractor personnel, if approved, shall be with personnel of equal ability, experience, and qualifications. The Contractor will be responsible for any expenses incurred in familiarizing the replacement personnel to insure their being productive to the project immediately upon receiving assignments. Approval of replacement personnel shall not be unreasonably withheld. The Procuring Agency shall retain the right to request the removal of any of the Contractor's personnel at any time.

20. Subcontracting: The Contractor shall not subcontract any portion of the Price Agreement without the prior written approval of the Procuring Agency. No such subcontracting shall relieve the Contractor from its obligations and liabilities under this Price Agreement, nor shall any subcontracting obligate payment from the Agency.

21. Records and Audit: The Contractor shall maintain detailed time and expenditure records that indicate the date, time, nature, and cost of services rendered during this Price Agreement's term and effect, and retain them for a period of three (3) years from the date of final payment under this Price Agreement. The records shall be subject to inspection by the Agency, State Purchasing Division, Department of Finance and Administration, and for Information Technology contracts, State Chief Information Officer. The Agency shall have the right to audit billings, both before and after payment. Payment for services under this Price Agreement shall not foreclose the right of the Agency to recover excessive or illegal payments.

22. Subcontracts: The foregoing requirements for Contractor Personnel, Subcontracting, and Audit shall be inserted into all subcontracts from the prime contractor to the subcontractor.

New Mexico Employees Health Coverage

A. If Contractor has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, Contractor certifies, by signing this agreement, to have in place, and agrees to maintain for the term of the contract, health insurance for its New Mexico Employees and offer that health insurance to its New Mexico Employees if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceeds \$250,000 dollars.

B. Contractor agrees to maintain a record of the number of its New Mexico Employees who have (a) accepted health insurance; (b) declined health insurance due to other health insurance coverage already in place; or (c) declined health insurance for other reasons. These records are subject to review and audit by a representative of the state.

C. Contractor agrees to advise all of its New Mexico Employees of the availability of State publicly financed health care coverage programs by providing each of its New Mexico Employees with, as a minimum, the following web site link to additional information: <http://www.insurenwnewmexico.state.nm.us/>.

D. For purposes of this Paragraph, the following terms have the following meanings:

- (1) "New Mexico Employee" means any resident of the State of New Mexico employed by Contractor who performs the majority of the employee's work for Contractor within the State of New Mexico, regardless of the location of Contractor's office or offices; and
- (2) "offer" means to make available, without unreasonable restriction, enrollment in one or more health coverage plans and to actively seek and encourage participation in order to achieve the goals of Executive Order 2007-049. This could include State publicly financed public health coverage programs such as *Insure New Mexico!*

New Mexico Pay Equity Initiative

Contractor agrees, if it has ten (10) or more New Mexico employees OR eight (8) or more employees in the same job classification, at any time during the term of this contract, to complete and submit the PE10-249 form on the annual anniversary of the initial report submittal for contracts up to one (1) year in duration. If contractor has (250) or more employees, contractor must complete and submit the PE250 form on the annual anniversary of the initial report submittal for contracts that are up to one (1) year in duration. For contracts that extend beyond one (1) calendar year, or are extended beyond one (1) calendar year, contractor also agrees to complete and submit the PE10-249 or PE250 form, whichever is applicable, within thirty (30) days of the annual contract anniversary date of the initial submittal date or, if more than 180 days has elapsed since submittal of the last report, at the completion of the contract, whichever comes first. Should contractor not meet the size requirement for reporting at contract award but subsequently grows such that they meet or exceed the size requirement for reporting, contractor agrees to provide the required report within ninety (90) days of meeting or exceeding the size requirement. That submittal date shall serve as the basis for submittals required thereafter.

Contractor also agrees to levy this requirement on any subcontractor(s) performing more than 10% of the dollar value of this contract if said subcontractor(s) meets, or grows to meet, the stated employee size thresholds during the term of the contract. Contractor further agrees that, should one or more subcontractor not meet the size requirement for reporting at contract award but subsequently grows such that they meet or exceed the size requirement for reporting, contractor will submit the required report, for each such subcontractor, within ninety (90) days of that subcontractor meeting or exceeding the size requirement. Subsequent report submittals, on behalf of each such subcontractor, shall be due on the annual anniversary of the initial report submittal. Contractor shall submit the required form(s) to the State Purchasing Division of the General Services Department, and other departments as may be determined, on behalf of the applicable subcontractor(s) in accordance with the schedule contained in this paragraph. Contractor acknowledges that this subcontractor requirement applies even though contractor itself may not meet the size requirement for reporting and be required to report it self.

Two copies of the Pay Equity Worksheet shall be submitted prior to Award by the prospective Awarded Vendor.

Statewide Price Agreement

Article I – Statement of Work

Under the terms and conditions of this Price Agreement all State of New Mexico agencies, commissions, institutions, political subdivisions and local bodies allowed by law may issue orders for items and/or services described herein. The terms and conditions of this Price Agreement shall form a part of each order issued hereunder.

The items and/or services to be ordered shall be as listed under Article IX - Price Schedule. All orders issued hereunder will bear both an order number and this Price Agreement number. It is understood that no guarantee or warranty is made or implied by the New Mexico State Purchasing Agent, his/her designee or the user that any order for any definite quantity will be issued under this Price Agreement. The Contractor is required to accept the order and furnish the items and/or services in accordance with the articles contained hereunder for the quantity of each order.

Article II – Term

The term of this Price Agreement, for issuance of orders, shall be as indicated in the specifications.

Article III – Specifications

Items and/or services furnished hereunder shall conform to the requirements of specifications and/or drawings applicable to items listed under Article IX-Price Schedule. Orders issued against this schedule will show the applicable Price Agreement item(s), number(s), and price(s); however they may not describe the item(s) fully.

Article IV – Shipping and Billing Instructions

Contractor shall ship in accordance with the following instructions: Shipment shall be made only against specific orders which the user may place with the Contractor during the term; The Contractor shall enclose a packing list with each shipment listing the order number, price agreement number and the commercial parts number (if any) for each item; Delivery shall be made as indicated on page 1. If vendor is unable to meet stated delivery the State Purchasing Agent or his/her designee must be notified.

Article V – Termination

The Agency may terminate this Agreement for convenience or cause. The Contractor may only terminate this Agreement based upon the Agency's uncured, material breach of this Agreement. Contractor shall give Agency written notice of termination at least thirty (30) days prior to the intended date of termination, which notice shall (i) identify all the Agency's material breaches of this Agreement upon which the termination is based and (ii) state what the Agency must do to cure such material breaches. Contractor's notice of termination shall only be effective (i) if the Agency does not cure all material breaches within the thirty (30) day notice period or (ii) in the case of material breaches that cannot be cured within thirty (30) days, the Agency does not, within the thirty (30) day notice period, notify the Contractor of its intent to cure and begin with due diligence to cure the material breach. Termination of this Contract, however, shall not affect any outstanding orders. This provision is not exclusive and shall not waive other rights and remedies afforded either party in the event of breach of contract or default. In such instances the contract may be cancelled effective immediately.

Article VI – Amendment

This Price Agreement may be amended by mutual agreement of the New Mexico State Purchasing Agent or his/her designee and the Contractor upon written notice by either party to the other. An amendment to this Price Agreement shall not affect any outstanding orders issued prior to the effective date of the amendment as mutually agreed upon, and as published by the New Mexico State Purchasing Agent or his/her designee. Amendments affecting price adjustments and/or the extension of a price agreement expiration date are not allowed unless specifically provided in the bid and price agreement specifications.

Article VII – Indemnity Clause

Contractor shall indemnify and hold harmless the State, its officers and employees, against liability, claims, damages, losses or expenses arising out of bodily injury to persons or damage to properties caused by, or resulting from Contractor's, and/or its employees, own negligent act or omission while Contractor, and/or its employees, perform or fails to perform its obligations and duties under the Terms and Conditions of this agreement. This save harmless and indemnification clause is subject to the immunities, provisions, and limitations of the Tort Claims Act (Section 41-4-1, et seq., N.M.S.A. 1978 comp. and Section 57-7-1 N.M.S.A. 1878 comp. and any amendments thereto.

It is specifically agreed between the parties executing this agreement that it is not intended by any of the provisions of any part of the agreement to create in the public or any member thereof a third party beneficiary or to authorize anyone not a party to the agreement to maintain a suit(s) for wrongful death(s), bodily and/ or personal injury(s) to person(s), damage(s) to property(ies) and/or any other claim(s) whatsoever pursuant to the provisions of this agreement.

Establish a Statewide Price Agreement for Police Vehicles, current year models.

The term of this Price Agreement for issuance of orders shall be one (1) year from date of award through the manufacturer's current "build out date", with an option to extend for a period of up to three (3) additional years, on a year-by-year basis, by mutual agreement of all parties and approval of the New Mexico State Purchasing Director at the same price, terms and conditions. This Price Agreement shall not exceed four (4) years.

Escalation Clause:

In the event of a product cost increase an escalation request will be reviewed by this office on an individual basis. Please be aware this measure is not intended to allow any increase in profit margin, only to compensate for an actual cost increase. Increases will only be considered on an annual basis and when the contractor provides proof from the manufacturer of the increase.

Definition:

"Build out date" when manufacturer stops accepting orders.

Vendors to indicate build out date: * _____ (*build out date" may be a factor on award).

The following conditions shall apply to all items:

- A. Bidder must be an authorized dealer, and have parts and service facilities within the state of New Mexico.
- B. Units shall be new current production year models.
- C. All specifications are minimum.
- D. Units shall meet all federal and state legal requirements
- E. Units shall include all standard items as listed in manufacturer's literature.
- F. Units furnished shall be completely assembled, serviced, and ready for operation as required by the manufacturer and the user agency.
- G. Units shall carry the manufacturer's standard warranty. Warranty shall apply from the date the unit is accepted and approved by the user agency as meeting all specifications.
- H. Units are to be transported to the dealer's place of business, rather than driven.
- I. All ordered options shall be installed as requested.
- J. Award shall be based on total net cost, F.O.B. Santa Fe, New Mexico.
- K. All subcontractors must show proof of current product liability insurance.
- L. Requested delivery: within approximately 120 working days ARO; subject to manufacturer production schedules.
- M. All vehicles shall include all OEM equipment as supplied by the manufacturer, unless otherwise specified in Price Agreement specifications.
- N. Prior to delivery of vehicle(s) to user agency, all fuel tanks and reservoirs must be filled to full capacity.
- O. Awarded vendor shall acknowledge receipt of purchase order to ordering agency within two (2) working days. Verbal orders are not valid. Likewise, user must verify receipt of purchase order by vendor.
- P. The New Mexico Purchasing Division reserves the right to add or delete options and/or negotiate the price of options if it is to the best interest of the State of New Mexico.

NOTE: All quantities are approximate.

It is the purpose of these specifications to describe various vehicles to be used in police patrol service. These vehicles will be operated for long periods of time at normal traffic speeds, with frequent periods of idling; however, the vehicles must also be capable of fast acceleration and high-speed performance. For this reason, the vehicles must have outstanding handling characteristics, cooling systems and brake systems.

The manufacturer, in the selection and engineering of components, will use materials and design practices that will produce the best vehicle in the industry for the type of operation to which the vehicle will be subjected.

Component parts and design shall be of the quality that will give maximum performance, durability and safety, and not merely meet minimum requirements of the specification.

The vehicles shall, in all aspects, meet or exceed all requirements of the federal government for the year model bid. The following specifications are required on each vehicle unless the specific model specifications listed on the items has a distinct requirement.

Definition:

The term "heavy duty", as applied to these specifications, shall be interpreted to mean: the item to which the term is applied shall exceed the usual quantity, quality or capacity supplied with standard production vehicles and shall be able to withstand unusual strain, exposure, temperature, wear and use.

Engine Cooling:

Engine cooling system shall be designed to withstand high speed operation for extended periods of time and give adequate cooling when the vehicle is "at rest" after high speed operation and during long periods of idling.

Front License Bracket:

Vehicles shall be equipped with a front license plate bracket on front bumper.

Illustrative and Technical Data:

Bidder to submit, with bid illustrative product brochures and technical data on vehicles and equipment proposed to be furnished.

Instruments: (Pursuit rated vehicles only)

Speedometer:

Head (including face) shall be specially calibrated by the speedometer manufacturer and be accurate within two (2) miles per hour throughout its speed range. Manufacturer shall provide written certification of speedometer accuracy within two (2) miles per hour. Face shall be easy to read.

Keys and Locks:

A. There shall be three (3) keys for each vehicle (with an option of ordering additional keys at agencies cost)

B. Same key for all locks on each vehicle.

C. Different key for each vehicle.

D. Key code shall be attached to at least one (1) key delivered with the vehicle.

E. Rear door interior handles shall be designed to be rendered inoperable from the rear passenger compartment by means of childproof locks that is activated from outside the rear passenger compartment. If such childproof locks are not available, then the rear door interior handles shall be rendered inoperable by removal of the handle activation rod. Handle activation rods will be provided to the purchaser at the time of delivery.

Legal Requirements:

All exceptions to these specifications shall be listed on a separate sheet of paper.

The State of New Mexico shall have the final decision of acceptability of the product; the burden of proof shall be upon the vendor.

Lights: (Pursuit rated vehicles only)

- A. It shall be possible to turn dome and map lights on and off with the doors closed.
- B. Dome and map lights shall be of such intensity that they are capable of providing adequate light to read a standard road map while sitting in the driver's seat at night.
- C. An additional dome light with switch shall be mounted between the sun visors. It shall operate independent of standard equipment dome lights (if available).
- D. Inside – adjustable for day or night driving and free of visual distortion.
- E. Outside – left and right side mirrors mounted on the front doors.

Manufacturing of Vehicles:

It is intended that the vendor shall require the manufacturer to build the vehicles to these specifications and that the vendor will only be required to perform the pre-delivery service and not to be required to modify, alter, exchange or install various components to correct such deficiencies. Since these vehicles will be used for police service, they shall be equipped with the manufacturer's "police package".

Ornamentation Advertising:

No dealer advertisement shall be displayed on the exterior or affixed to the interior of the vehicle.

Pre-Delivery:

The first delivery of vehicles will be inspected by the User Agency's Fleet Manager or his representative prior to acceptance, to ensure that all conditions of these requirements are met. 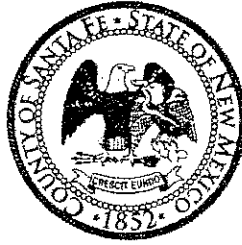

Re: Request approval of the Collective Bargaining Agreement between the County of Santa Fe and the American Federation of State, County and Municipal Employees (AFSCME), New Mexico Council 18 (referring to the bargaining unit as local #1413-M)

BACKGROUND AND SUMMARY

The Santa Fe County Management Team and the AFSCME Council 18 (referring to its bargaining unit as Local 1413M) have negotiated the financial re-opener in compliance with the collective bargaining agreement. Please note that at the request of AFSCME, the contract refers to the bargaining unit as AFSCME Council 18, Local #1413M, however the Certification of Representation only refers to AFSCME Council 18. The parties have worked diligently together to come to a mutual agreement in the best interest of the County and our employees. The agreed upon language provides union employees with a new starting pay that will assist with the recruitment and retention of quality employees, cost of living adjustments comparable to other county employees, an enhanced differential pay to compensate Registered Nurses and Licensed Practical Nurses during peak hours, and the opportunity for either party to open one (1) economic article no earlier than May 2018 and no later than July 2018.

ACTION REQUESTED

The action requested is approval of amendment no.1 the Collective Bargaining Agreement between the County of Santa Fe and the American Federation of State, County and Municipal Employees (AFSCME) New Mexico Council 18 (referring to the bargaining unit as local #1413-M)

**AMENDMENT NO. 1 TO COLLECTIVE BARGAINING AGREEMENT BETWEEN
SANTA FE COUNTY, NEW MEXICO AND THE AMERICAN FEDERATION OF
STATE, COUNTY, AND MUNICIPAL EMPLOYEES; COUNCIL 18 (REFERRING TO
THE BARGAINING UNIT AS LOCAL 1413-M)**

THIS AMENDMENT is made and entered into as of this _____ day of _____, 2017, by and between Santa Fe County, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and the American Federation of State, County, and Municipal Employees (hereinafter referred to as "the Union").

WHEREAS, the County and the Union entered into the Collective Bargaining Agreement ("CBA") effective December 13, 2016 to December 31, 2020; and

WHEREAS, the CBA provides for a financial reopener scheduled to be negotiated beginning no earlier than May 1, 2017, and no later than June 1, 2017; and

WHEREAS, the parties have agreed upon certain financial provisions and now desire to amend the CBA to incorporate such provisions.

NOW, THEREFORE, THE PARTIES AGREE TO ADD THE FOLLOWING PROVISION TO THE CBA.

1. The following shall be added as a new Section 2 to Article 22 of the CBA; the remainder of Article 22 shall remain the same:

ARTICLE 22. WAGES

Section 2. Retention and Recruitment Adjustment

- A. Bargaining unit Registered Nurses will earn a minimum salary of \$34.50 per hour and Licensed Practical Nurses will earn a minimum salary of \$25.00 per hour effective the first full pay period after ratification by the bargaining unit and approval by the Board of County Commissioners. Bargaining unit employees who are earning the minimum pay or more shall receive a \$0.50 salary increase effective the first full pay period after ratification by the bargaining unit and approval by the Board of County Commissioners.
 - B. All bargaining unit employees shall receive a 3% COLA effective the first full pay period in January 2018.
 - C. Bargaining unit employees will receive cost of living adjustments comparable to non-bargaining unit employees in January 2019 and January 2020.
2. The current Article 23 of the CBA shall be deleted in its entirety and replaced with the following:

ARTICLE 23. PAY DIFFERENTIAL

- A. Licensed Practical Nurses and Registered Nurses whose normal schedule is the graveyard shift, not including Friday or Saturday nights, will receive shift differential pay of 2% of their hourly rate for hours worked.
 - B. Licensed Practical Nurses and Registered Nurses who work on Saturday or Sunday day shifts will receive shift differential pay of \$0.50 per hour.
 - C. Licensed Practical Nurses and Registered Nurses who work Friday or Saturday graveyard shifts will receive shift differential pay of \$0.50 per hour.
 - D. Notwithstanding the provisions of this Article 23, shift differential pay shall not be counted towards PERA benefits.
3. The current Article 27 of the CBA shall be amended to include the addition of a final sentences to this Article; all other provisions of Article 27 shall remain the same:

ARTICLE 27. TERM OF AGREEMENT

Each party has the right to open one (1) economic article, which may be opened no earlier than May 2018 and no later than July 2018. All items in this financial package are contingent upon sufficient budget appropriation.
