## **SUMMARY:**

This is a request to conduct the second of two required public hearings for the submittal process of Santa Fe County's 2017 Infrastructure and Capital Improvements Plan (ICIP) for Fiscal Years 2019-2023.

#### **BACKGROUND:**

Santa Fe County annually submits an ICIP to the New Mexico Department of Finance and Administration (DFA). The ICIP is required of all local governments for inclusion of potential projects in the New Mexico Legislature's capital outlay process. The County's 2017 ICIP for Fiscal Years 2019-2023 is due to DFA on or before September 1, 2017.

On May 2, 2017, the BCC reviewed the ICIP public outreach process and schedule. Staff has conducted public meetings throughout the County and received suggestions for capital projects to be included in the County's capital planning process. On July 11, 2017, the BCC reviewed the draft list of projects at the first ICIP public hearing.

This agenda item includes the holding of the second of two public hearings on the 2017 ICIP for fiscal years 2019-2023 and the request of the BCC to prioritize the top five projects for this year's submittal. Staff is also requesting the BCC direct staff to submit the final ICIP plan with top five priorities to DFA along with a resolution to memorialize the decisions, which will be the next item on this agenda.

As of the date of this memo, staff is compiling the revised draft ICIP list. Staff will provide the BCC a revised draft list of potential 2017 ICIP projects for fiscal years 2019-2023 at the August 8, 2017 BCC meeting.

#### **SUMMARY:**

This is a request to approve the require Resolution adopting the Santa Fe County's 2019-2023 Infrastructure and Capital Improvements Plan (ICIP) as required per the New Mexico Department of Finance and Administration (DFA) ICIP submittal process.

#### **BACKGROUND:**

Santa Fe County annually submits an ICIP to the New Mexico Department of Finance and Administration (DFA). The DFA submittal process requires that the Board of County Commissioners (BCC) adopt the annual ICIP via a formal resolution. The County's 2019-2023 ICIP is due to DFA by September 1, 2017.

On May 2, 2017, the BCC reviewed the ICIP public outreach process and schedule. Staff has conducted public meetings throughout the County and received suggestions for capital projects to be included in the County's capital planning process. On July 11<sup>th</sup>, 2017 and August 8<sup>th</sup>, 2017, the BCC reviewed the draft list of projects at the first and second ICIP public hearings.

At the August 8<sup>th</sup>, 2017 Public Hearing, staff requested that the BCC review the ICIP for fiscal years 2019-2023 and prioritize the top five projects for this year's submittal. Adoption of this resolution formalizes the ICIP final list of projects and directs staff to submit the County's 2017 ICP for Fiscal Years 2019-2023. The approved ICIP will be attached with this resolution as Exhibit A, pending BCC final approval.

WHEREAS, the Board reviewed the list of potential projects at public meetings on July 11<sup>th</sup>, 2017 and August 8<sup>th</sup>, 2017.
