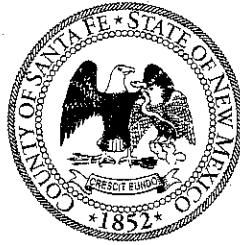

### SUMMARY

This letter of support is for the work conducted by the Santa Fe Habitat for Humanity (SFHFH) and their application to the New Mexico Mortgage Authority for New Mexico Affordable Housing tax credits. SFHFH has been working in the Santa Fe community since 1987, and has constructed 109 homes for the lowest income citizens.

### ACTION REQUESTED

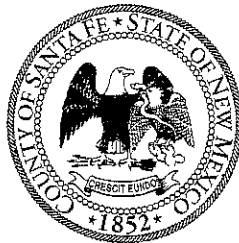
Request that the Santa Fe County Board of Commissioners approve the letter of support for the SFHFH.

SFHFH has been working in the Santa Fe community since 1987, and has constructed 109 homes for the lowest income citizens.
