Re: SLDP Revisions

Summary

Outlined below are the proposed revisions to Chapters 7-15 of the Sustainable Land Development Plan that were included in the draft submitted to the CDRC on April 22nd. The proposed revisions identified through this memo outline the majority of the changes that staff is recommending.

Chapter 7: Renewable Energy and Energy Efficiency Element

Revise Chapter 7 to include the following:

- 1. Make Edits for clarification
- 2. Revise Key Issues and Keys to Sustainability
- 3. Restructure for consistency
- 4. Revise Section 7.2.1 EXISTING CONVENTIONAL ENERGY to include additional information about existing electric sources, existing conditions and interconnections.
- 5. Clarify solar section to indicate the number of full sun hours received approximately 6 full sun hours per day
- 6. 7.2.2.6 Renewable Energy Infrastructure section-Revised to clarify Utility Scale and Local Scale
- 7. Revise Renewable Energy Potential Map 7-1 into two maps, Map 7-1A RENEWABLE ENERGY POTENTIAL-SOLAR AND WIND and MAP 7 1-B: RENEWABLE ENERGY POTENTIAL-BIOMASS AND GEOTHERMAL. Add biomass energy potential on the Renewable Energy map. Revise the map and symbols to be more legible (this map was broken into two renewable energy maps, Solar & Wind vs. Biomass and Geothermal, as a result).
- 8. Revise Directives to ensure consistency between elements of plan and plan directives

- 9. Add Goal 18: Reduce greenhouse gas emissions and dependence on non-renewable energy use.
- 10. Categorize policies and categories under goal 18:
 - a. Renewable Energy
 - b. Energy Efficiency
- 11. Add Goal 20: Create a Viable Green Energy Economy and Community

Revise Chapter 8 to include the following:

 Compost has benefits to the environment and economy for replenishment of soils,
 minimization of erosion, development of high-nutrient foods, and reduction of water irrigation need.
 - 6. Provide designated areas to use recycled materials and transform them into new materials.
 - 7. Utilize local resources for building materials and establish a catalog of available recycled materials.
 - 8. Promote Durability and longevity in the design and construction of residential and commercial structures.
 - 9. Establish "traditional markets", creating options to have building materials brought in for sale or other initiatives.

Delete Tables identified in Figure 12-1 Annual Fiscal Impacts at Year Stated-Normal Finance Mechanisms and Figure 12-2: Annual Fiscal Impacts at Year Stated Annual Fiscal Impacts at Year Stated Utilizing PIDs, Impact Fees, Utility Districts. These tables identify impacts based on SDA areas that have been changed. This information can be calculated and incorporated after the SDA's have been finalized.
- 6. Revise Figure 12 4: Existing Public Facilities Existing Levels of Service Standards-The number of firefighters per 1,000 residents was incorrect. The correct number is 1.09 firefighters per 1,000 residents.
- 7. Revise Map 12-1, Community Facilities: Map to be more clear and legible

8. Revise Map 12-2, Capital Improvements Projects: Remove CIP project numbers from the map. The draft CIP projects are conceptual only at this time and have not gone through a public process and have not been approved by the Board.

Summary and Recommendations

Staff recognizes that there are a number of unresolved issues that have been identified and will be presented at the Public Hearings. Some of these recommendations are specific and need to be developed into programs. Staff needs to further evaluate the public recommendations to determine whether they can be brought into SLDP or are best addressed through the Strategic Work Plan or could be addressed in the SLDC. There are additional recommendations that should be considered for these chapters that need to be reviewed through the County prior to final recommendations.

Staff recommends that the CDRC consider all public comments and will bring final recommendations forward to the CDRC at future Public Hearings.
