### MINUTES OF THE

### November 27, 2012

This meeting of the Santa Fe County Housing Authority was called to order on the above-cited date in the Santa Fe County Legal Conference Room, at the County Courthouse at approximately 10:05 a.m. by County Commission Chair Liz Stefanics.

Roll call indicated the presence of a quorum with the following Board members present:

### III. Introductions

Those present introduced themselves.

### IV. Approval of Agenda

Commissioner Holian moved to approve the agenda as published. Commissioner Mayfield seconded, and the agenda was unanimously [7-0] approved.

### **Member(s)** Excused:

None

### V. <u>Approval of Minutes</u>: September 25, 2012

Commissioner Mayfield moved to approve the minutes from the above-cited date as presented. His motion was seconded by Commissioner Holian and passed by unanimous [7-0] voice vote.

VI. <u>Action</u>: Resolution 2012-23HA, a resolution granting the executive director signature authority to execute amendment #1 to the performance agreement between Santa Fe County Housing Authority and Life Link to administer portions of the Bridge Program, a voucher-based rental assistance program

Mr. Pacheco explained the resolution allows him to sign an agreement to continue supporting a program that helps people who have traumatic brain injury. It has to be signed on an annual basis; this is the second year. He had copies of the resolution available.

Commissioner Holian asked if there was a limited number of vouchers and Mr. Pacheco said there was. Tracey Young stated only two were in use presently. The program is different from the Linkages program which is continuous funding. Everyone that Life Link has sent under this program is being helped, but they haven't sent many people.

Recalling Hank Hughes' comments from the previous month regarding the number of homeless people with mental issues, Chair Stefanics expressed surprise that so few people were being referred. Mr. Pacheco said the Housing Authority does not do the qualifying, so he was unable to comment. Chair Stefanics suggested that outreach be done. Ms. Ong noted that her son goes to Life Link and he has never heard of the program. Mr. Pacheco said he would look into it.

Commissioner Vigil moved to approve the resolution and Commissioner Holian seconded. The motion passed unanimously [7-0].

### VII. Housing Authority Updates

### A. Site Improvement Plan/CFP Update

Victor Gonzales stated the replacement cabinets have been ordered and will be installed probably late December. A BAR will be needed for architectural and engineering services at Camino Jacobo. Sewer lines are being replaced at Camino de Jacobo and Santa Cruz. Two large trees were removed that were causing damage. A unit was renovated for handicap access on San Mateo Way.

Chair Stefanics said she would like to be present to see the cabinet replacements.

Mr. Gonzales said a private contractor is helping decrease the turnaround rate of units in order to lower the vacancy rate.

Commissioner Anaya indicated he would like monthly reports of total capital dollars by

fund year with expended balance in order to get a better handle on what's been contracted and what's been spent, perhaps in the form of a spreadsheet. Mr. Pacheco said Ms. Young already has forms that can be adjusted for meeting presentation.

### VII. B. Vacancy Update

Mr. Pacheco referred to the packet and said the vacancy rate is slightly higher which is typical for this time of year. They are working on lowering turnaround time but with the holidays staff is reduced. That is the reason for using contractors.

### VII. C. Director's Report

Mr. Pacheco thanked Ms. Young for the work done on the depository agreement that is now complete and they are in compliance with all HUD regulations.

Mr. Pacheco pointed out that 18 families were provided with complete meal packages this Thanksgiving and he commended Ms. Lopez for working on that. She is also in charge of the Joshua trees. He added 2/3 of the names on the tree are already gone. He also recognized the Board's support for that program, through which 200 kids will receive gifts from County employees.

Chair Stefanics asked if anything was done for the parents and Mr. Pacheco said he was not aware of anything other than the weekly commodity distributions.

Residents are being advised they are not to remove batteries from smoke and carbon monoxide detectors. This information is in the newsletter and in the leases. About 2/3 of the residences have detectors. Commissioner Mayfield asked if the detectors are hard-wired. Mr. Gonzales said each unit has a hard-wired smoke detector in the hallway and the others are battery-operated. CO detectors are hard-wired or plug-in. Mr. Pacheco said they will make sure that all homes for sales have detectors. Commissioner Holian said she appreciated the work done on this and recommended it be mentioned at the resident meetings.

Commissioner Mayfield asked about fire extinguishers and Mr. Pacheco said he believed the units did not have them. Commissioner Mayfield suggested they be provided and noted the Fire Chief may know about donations. Mr. Pacheco said there have been fires in the units and one did burn down. Ms. Ong advised that training be given since people don't know how to use them. Ms. Miller agreed that improper use can be a problem so training is essential.

A discussion ensued regarding Neighborhood Watch programs. Mr. Pacheco said he believed it was not officially organized but neighbors were keeping an eye out. Chair Stefanics pointed out the newsletter made reference to Neighborhood Watch meetings. Mr. Pacheco said sheriffs are living at each neighborhood. Ms. Ong said there was a presentation but no follow-through. Mr. Pacheco said he would look into the situation and report back.

Mr. Pacheco said he has spoken with the Public Information Officer to make clear the distinction between the affordable housing program and the Housing Authority. A link is being

added to the landlord-tenant hotline.

Chair Stefanics asked why there are complaints about the mailboxes getting too full. Mr. Pacheco stated that could be from people not living in the units or away from the unit. He said they monitor to make sure the units are being lived in. Ms. Ong said there are lots of advertisements and the boxes are small. Another problem is mail for past residents is delivered.

Commissioner Mayfield suggested the post office be notified when a tenant has moved. There are ways to get off junk mail lists, and Mr. Pacheco stated he would look into that.

### IX. Public Comments

None were offered.

### X. Matters from the Board

Commissioner Anaya asked if it would be possible to get the minutes earlier. Ms. Miller noted if there are immediate questions her office can circulate answers the next day. Mr. Pacheco added they sometimes request the minutes be expedited.

Regarding the presentation on procurement, Commissioner Anaya asked there be information be provided on that topic across the board.

Commissioner Anaya asked there be follow-up on seeking funding from 202, 504, 811, and 542 sources. He pointed out keeping on top of availability could provide funding opportunities. Mr. Pacheco said he would be happy to do that.

Referring to the roads within the public housing sites, Commissioner Anaya indicated that they were adopted by the County Public Works in order not to draw funds from housing dollars. He asked for an update on the long-range plan for upgrading the roads. He noted Camino Jacobo is not a city road although it has city utilities under it. He said fixing the sewer line is a huge problem and a health and safety issue. Mr. Gonzales said they did a BAR on that but money needs to be allocated.

Commissioner Anaya asked to be kept updated on that in case City officials need to be brought in. Mr. Pacheco said he spoke to the Mayor and the City Manager regarding jurisdictional matters with the Civic Housing Authority. The Mayor understood the issue and was supportive. However, he did not bring up the sewer issue.

Commissioner Anaya remarked that over the years they had provided fire extinguishers but they disappeared or were misused. "It is a difficult item to manage." There needs to be training, recharged and inspected. He suggested looking into what other housing authorities do.

Commissioner Anaya noted there used to be an organized Neighborhood Watch program. The Sheriff is available to reinvigorate it. He agreed on the value of the Joshua Tree program and agreed that perhaps something could be done for the adults, perhaps starting next year. Commissioner Anaya asked that other staff from the Housing Authority be invited to meetings to provide input at meetings.

Mr. Vigil suggested there be trainings on the symptoms of CO poisoning. Mr. Pacheco

said that could be done at the monthly meetings.

Commissioner Mayfield requested Housing Authority meetings occasionally be held at the housing sites.

### XI. Executive Session: Personnel Matters

Commissioner Vigil moved to go into executive session to discuss personnel matters. Commissioner Holian seconded.

The motion to go into executive session pursuant to NMSA Section 10-15-1-H (2) to discuss the matter delineated above passed upon unanimous roll call vote with Commissioners Anaya, Holian, Mayfield, Vigil and Stefanics and Mr. Vigil and Ms. Ong all voting in the affirmative.

[The Authority met in closed session from 10:45 to 11:05.]

Commissioner Vigil moved to come out of executive session where only personnel matters were discussed. Commissioner Mayfield seconded and the motion carried by unanimous [6-0] voice vote. [Commissioner Holian was not present for this action.]

### XII. Adjournment

Having completed the agenda and with no further business to come before the Authority, this meeting adjourned at approximately 11:05 a.m.

### Cabinet Replacements at the Valle Vista Site

A Notice to Proceed was issued on January 7, 2013. The removal of old cabinets and the installation of new cabinets have begun at the Valle Vista Site. The project should be completed by early April and will include thirty-seven (37) units. This project also includes the replacement of vanities, faucets, sinks and countertops in each of the 37 units.

### Extension of the Main Sewer Line at the Jacob D. Martinez Site

A meeting was held with Roy Woods and Paul McGinnes, Engineer, on January 3, 2013. A walk through of the Jacob D. Martinez site was completed the same day. Santa Fe County has a surveyor on contract that will be hired to work in conjunction with the contractor. Mr. McGinnes will meet with appropriate staff at the City of Santa Fe, Public Works Division, to determine where to tie into the existing main-line off of Lopez Lane. Mr. Woods stated it will be the responsibility of the City of Santa Fe to maintain the main line through the Jacob D. Martinez Site subsequent to the completion of the project.

### Sewer Lines in Santa Cruz

A discussion with James Kolidin at Sub-Surface Construction was held to see if Santa Fe County can partner on a current open contract with the City of Santa Fe for underground construction work. Mr. Kolidin met with Bill Euwey of the City of Santa Fe's Waste Water Division. Mr. Euwey approved the sharing of their contract with Sub-Surface Construction. Mr. Kolidin will perform a detailed walk through of the site with staff to determine which part of the City's contract we can share (piggy back) for completion of this underground project.

### Update on Assistance with Unit Turn Around for Six Public Housing Units

A Purchase Order was issued on January 14, 2013 to Sol Systems Builders, LLC. Sol Systems began working on unit rehabilitation on Friday, January 18, 2013. Staff is monitoring the work and is satisfied that the project is progressing at a good rate. The project should be completed by mid-February.

### Information on Fire Extinguishers at Other Housing Authorities

I spoke with Frank Lucero, Maintenance Supervisor, at the City of Las Vegas Housing Authority in regards to the question that was raised in November by the Santa Fe County Housing Authority Board. Mr. Lucero stated the Las Vegas Housing Authority placed fire extinguishers in public housing units at one point. The fire extinguishers became a maintenance issue because they were taken from the units. Placement of fire extinguishers also became an adverse finding during the annual REAC inspection by HUD because REAC requirements state that if extinguishers are placed in one unit, then they must be in all units. Terry Baca, Executive Director of the Raton Housing Authority, stated that the Raton Housing Authority does not have extinguishers in their units due to the high costs of maintaining them.







### Free Income Tax Service to be Provided by The County Housing Authority

Two staff members of the Santa Fe County Housing Authority have received comprehensive training in the preparation of tax returns. These employees will provide tax preparation services to public housing clients and section-eight voucher holding clients by appointment during the upcoming tax season. Many of our public housing participants are elderly or lack transportation and we believe this service will be very helpful to them.

### The Search for Two Housing Board Members

The County Housing Authority has begun the process of submitting a formal request for two housing board members to replace Frankie Ong as the "resident" board member and to replace Tim vigil as the community "at large" member of the Housing Authority Board. The two year term for Ms. Ong has ended and the resignation of Mr. Vigil was submitted earlier at the beginning of this month (effective Dec. 28<sup>th</sup>). The Housing Authority would like to thank both of these members for their service on this important county board. At the February Housing Board Meeting candidate's names for both positions will be brought forward for consideration by the current Housing Board membership.

### Work on Potential Single Family Project Based Housing in Greater SF County

With prospective developments seeking approval to build homes in Santa Fe County staff is investigating the possibility of a potential affordable housing project that could include project based rental housing for low-income families wanting to participate in county public housing programs. This could include the possibility of mixed-income senior housing or mixed-income family housing. Staff would like to ask for direction from the Board regarding these possibilities in greater Santa Fe County.

### Update on Voucher Based Programs Including VASH, Linkages, Bridge and FSS

In addition to traditional section-eight vouchers the County Housing Authority administers several other voucher based programs to assist special populations in need of housing support that might not otherwise qualify for voucher assistance. These programs include the VASH (Veterans Affairs Supportive Housing), Linkages, Bridge and FSS (Family Self Sufficiency) with each program providing support for a targeted population in need of supportive housing and services.
