This meeting of the Santa Fe County Housing Authority was called to order on the above-cited date in the Santa Fe County Legal Conference Room, at the County Courthouse at approximately 10:50 a.m. by County Commission Chair Kathy Holian.

III. Introductions

Those present introduced themselves and Mr. Pacheco noted that Marcus MacDonald came on board recently and has been doing a great job.

IV. Approval of Agenda

Commissioner Chavez moved to approve the amended agenda. Mr. Loewy seconded and the motion passed by unanimous [6-0] voice vote.

V. Approval of Minutes: October 29, 2013

Mr. Loewy noted that under Housing Authority Updates the vacancy rate was listed at 96 percent; that should be 4 percent, or an occupancy rate of 96 percent.

Commissioner Chavez moved to approve the minutes as corrected. His motion was seconded by Chair Holian and passed by unanimous [6-0] voice vote.

VI. <u>Approval of Resolution 2013-13HB</u>: A Resolution Approving the Continued Occupancy by Police Officers for Valle Vista and Santa Cruz Public Housing Neighborhoods to Provide Security for Public Housing Residents

Mr. Pacheco said this resolution occurs annually as required by HUD in order to take the units out of occupancy inventory.

Commissioner Holian asked why Camino de Jacobo did not have an officer in residence. Mr. Pacheco said the Housing Manager felt there was sufficient law enforcement presence from the training done by police officers practicing SWAT operations. In response to questions from Commissioner Mayfield, Mr. Pacheco said the media is not notified of the trainings and rehearsals also occur at the other site when there are vacancies.

Commissioner Chavez moved to approve, Commissioner Mayfield seconded and the motion passed unanimously. [5-0] Commissioner Anaya was not present for this action.

VII. <u>Approval of Resolution 2013-14HB</u>: A Resolution Approving the Continued Use of a Public Housing Unit as a Community Center for Resident Services and Requesting a Waiver of the Performance Funding System

Mr. Pacheco said HUD also requires this resolution in order to use Unit 57 as a community center where commodities are staged along with other special activities.

Commissioner Anaya moved approval and Mr. Loewy seconded. The motion carried by unanimous [6-0] voice vote.

VIII. Housing Authority Updates

A. Site Improvement Plan/CFP Update

Mr. Gonzales indicating he has been speaking with the owner of the sewer easement by Camino de Jacobo. Mr. Pacheco said they are hopeful there will be a resolution shortly.

In other developments, Mr. Gonzales said they have been working on replacing cabinets at Valle Vista and remodeling bathrooms.

Commissioner Chavez pointed out there was a BCC agenda item regarding a contract for asbestos removal and asked if the contractors identified would be available to work at the housing sites. Mr. Gonzales said he was on the committee considering the bids and they will be on call. Mr. Pacheco said this will really help efficiency. They hope to engage roofers using the same system. Ms. Miller said when they do these types of on-call contracts Procurement advises all departments.

B. Upcoming Projects

Mr. Pacheco said some units at Valle Vista and Santa Cruz will be getting new cabinets and bathroom remodels. Staff is developing an RFP for this project.

C. Vacancy Update

Mr. Pacheco reported that the occupancy rate was holding at around 95 percent. This time of year is difficult to keep units occupied. Turnover is happening at a good pace.

D. Director's Report

Mr. Pacheco said he was happy to announce HUD has given approval for home sales proceeds to be used for pre-development construction and gap financing, temporary rental assistance for the situationally homeless, creation of a housing fund and deferred payment loans for energy efficiency improvements. Commissioner Anaya said this has been in the works for three years and will help make good use of the funds.

Additionally, the SEMAP test which has to be performed every two years was submitted and the Section 8 program scored 97 percent – 140 out of 145 possible points. He commended the Section 8 staff for their work.

Mr. Pacheco noted Larry Narvaiz is retiring and suggested means of expressing appreciation.

Mr. Pacheco thanked Deanna Lopez for her efforts in the holiday programs. Ms. Lopez said County emails were sent emails asking for help. They were able to buy Thanksgiving meals for 27 families. The Police Department provided 50 complete meals. Mr. Pacheco thanked everyone for their support.

IX. Matters from the Public

None were presented.

X. Matters from the Board

Commissioner Mayfield asked if commodities distributions could take place at all the sites. Mr. Pacheco said all residents are invited to Camino de Jacobo but they could look into the logistics.

Commissioner Anaya broached the matter of the narrow strip of land to the west of the Jacobo site. The owner, Mrs. Tsosie had at one time expressed a wish to donate the land, which would be great addition for the Boys and Girls Club. Mr. Pacheco said two families own the land, the Tsosies children and the Gillman Company. A discussion ensued regarding potential uses for the property.

XI. Executive Session

None were presented.

XII. Adjournment

Having completed the agenda and with no further business to come before the Authority, Chair Holian adjourned the meeting at approximately 11:22 a.m.

Extension of our Main Sewer Line at Jacob D. Martinez

A draft easement agreement has been sent to Mr. Brecher, the owner of a property on Camino Jacobo near the housing authority, for access to install a sewer drain-line through his property near the housing authority. The draft agreement sent at the beginning of this month outlines the location, length and width of the needed easement.

A survey of the granted easement plat will be included so that all the new descriptions and designated area will be shown on the new plat for the utility easement Right of Way (ROW) for Mr. Brecher's property.

Unit turnaround

Completion of the annually contracted unit turnaround was completed on December 17, 2013. Five public housing homes were completed during this process.

Cabinet Replacement at Valle Vista

Advertisement for Invitation to Bid for new cabinets at the Valle Vista Housing site will be posted on January 26th and 27th. With completion of this project the housing authority will have replaced two-thirds (2/3) of the original older cabinets in homes at this location. We will complete the remaining homes at this location next year.

On Call Roofing

Advertisement for the "on call roofing contractors" will be posted on January 18th and 19th. This will allow the housing authority to address roofing issues in a more efficient and economical way.

Bathroom Renovation at Santa Cruz Site





Homebuyer Training for Housing Authority Tenants

Staff conducted two homebuyer trainings on December 18 and January 9 with FSS participants and other tenants interested in pursuing homeownership. Seven clients attended each session. Steve Brugger and Spence Terrell, of LANB, made the presentations, with housing staff Valerie Huerta, Lorraine Fede and Rosemary Bailey also participating.

In Session 1, the following items were presented: 1) Pros and Cons of Homeownership – Deciding If It is Right for You; 2) Explanation of County Assistance Programs for Homeownership; 3) Creating a Household Budget; 4) Understanding Credit & How Scores Are Calculated; 5) Impact of Credit Scores on Home Purchasing Power; 6) How to Correct or Improve Items on Your Credit Report.

In Session 2, the training focused on the following: 1) Factors That Affect the Amount of Monthly Mortgage Payment; 2) Neighborhood and Housing Characteristics Influencing What Type of Home to Buy; 3) Typical rovisions of a Purchase Agreement; 4) Review of Typical Closing Costs and Settlement Charges and HUD-1 Settlement Statement; 5) Timeline for Mortgage Loan Application and Approval.

As a result of the trainings, staff is currently working with one tenant interested in purchasing a home in Valle Vista.

Since the BCC instructed staff to proceed with the release of a Request for Proposals for the County-owned site at 2600 Galisteo on September 24, staff has been working with the New Mexico Environment Department Petroleum Storage Tank Bureau and the County's contractor, Glorieta Geoscience, Inc., to conduct an environmental assessment of site conditions at three underground storage tank systems that had been on-site. A "Continued Minimum Site Assessment" report was prepared and submitted to NMED on December 20, 2013. The results of the study were that all of the criteria required for NMED making a "No Further Action" determination have been met and that "Glorieta Geoscience, Inc. recommends

that the property be made available for unrestricted use including the potential for residential structures with permanent occupancy".

In addition, in November, the Department of Housing and Urban Development (HUD) approved the SFCHA request for use of home sales proceeds for a variety of programs, including "predevelopment, construction and limited, permanent gap financing at below market interest rates for development of rental or homeownership housing, to be used for projects on County-owned land...". During the BCC review of the components of the RFP, staff was encouraged to announce the availability of funding to assist in the development of an affordable housing project on the Galisteo Road property in the RFP. This approval from HUD enabled staff to respond to this BCC direction.

The Request for Proposals package that will be used to solicit private developer proposals for a mixed-income residential project on the subject site has been completed and has been released by the Procurement Division on January 24. A pre-proposal conference to review the RFP is scheduled for February 14. Following BCC direction to adhere to the City of Santa Fe Early Neighborhood Notification process, a meeting is being set up with the neighborhood for the week of February 10. At this meeting, staff will review the RFP and explain the County's purpose for making this land available for private development. Proposals will be due on March 28. The current schedule calls for approval of a land purchase/lease contract to be brought to BCC approval in June and to State Board of Finance for approval in July.

Joshua Tree Project

Due to the generosity of Santa Fe County employees participating in the Joshua Tree Program this Holiday Season, over two hundred (200) resident children in Public Housing sites. The gifts they purchased and donated made a difference for these families. In addition to providing gifts to children in this program, twenty-eight (28) seniors and families were provided Holiday food bags loaded with fruit, nuts, jam, cookies, candy, a coffee mug, and a kitchen towel.



Entry is through the door at the rear of the left side of the warehouse. On Thursday mornings, beginning at 6 am and continuing until all bags are distributed, no later than 9 am, often earlier, grocery bags of food are given without charge to those in need who enter the drive-through at the left to the loading dock in the rear of the building. Satellite Dishes

Please do not put satellite dishes on the down spouts or "canales" of the unit as it causes damage to the unit. A \$50 fine will be imposed on the tenant if damages occur when satellite dishes are installed. You are required to have a letter allowing you to get cable at your units before it is installed, you can get this from your housing managers.

Yard Inspections

Yard inspections will occur on a monthly basis at all sites. All residents are responsible for maintaining their yard. Repeated yard violations may result in your lease being terminated. It is a violation to place any items outside or against your unit (i.e. mattresses, freezers, dressers)

Attention Residents

All utilities that you are responsible for need to be connected at **ALL** times. Failure to keep them connected is a violation of your lease and may result in the termination of your lease.
