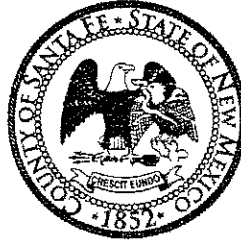

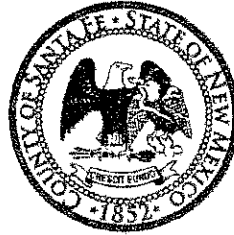

The winner will be announced during the Board of County Commission Meeting.

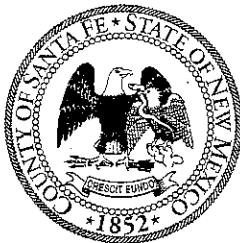

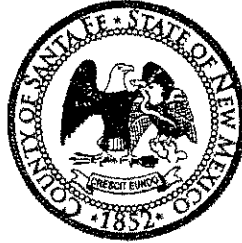
