### **Issue:**

The Stanley Cyclone Center has now been open for over two years. The Community Services Department recently hired a new Event Coordinator for that facility. And after evaluating the type of event requests, it has been suggested to add fees that pertain to nonprofit events, private events, and weddings.

# Background:

In December, 2016, the Board of County Commissioners approved a fee schedule for rentals / events at the Arena. This included private riding, open riding, 4H events, and riding with livestock. There have been recent requests to reduce the fees for events involving nonprofit entities. Also, the current fee schedule does not include fees for private events such as parties, etc. Lastly, for wedding requests, we are proposing a "package deal" to cover day before set up, day of event, and day after tear down.
