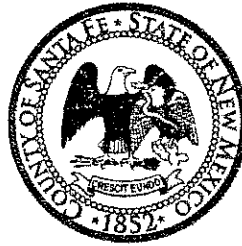

**Subject:** Resolution No. 2018-\_\_\_\_, A Resolution in Support of State of New Mexico Legislature Initiatives and Administrative Actions that Reduce Greenhouse Gas Emissions Through Energy Efficiency, Renewable Energy Production, Water Conservation and Watershed Management

---

### **Background and Summary:**

Consensus exists among the world's leading climate scientists that climate change caused by emissions of greenhouse gases from human activities is among the most significant problems threatening ecological stability and human well-being today. The Santa Fe Ski Basin Study Adaptations to Projected Changes in Water Supply and Demand identified that, as a result of greenhouse gas emissions, the native Rio Grande and Santa Fe River water supplies, on which the Santa Fe County's water utility depends, is projected to be reduced by approximately thirty-three percent (33%) by the 2050s, including a significant reduction in snowpack.

The Board of County Commissioners of Santa Fe (Board) is quite aware of this problem and has expressed its intent to support greenhouse gas emission reduction within the County and the community with numerous resolutions including most recently Resolution No. 2017-68 in which the County agreed to reduce greenhouse gas emissions per the targets set in the Paris Agreement.

By supporting and approving the attached resolution, the Board will be asserting, in no uncertain terms, that it supports various legislation that preserves our natural resources, raises renewable energy portfolio standards, reduces the state's electric utilities carbon footprint, enables community solar electric projects in New Mexico, etc.

### **Action Requested:**

**A RESOLUTION IN SUPPORT OF STATE OF  
NEW MEXICO LEGISLATURE INITIATIVES AND  
ADMINISTRATIVE ACTIONS THAT REDUCE  
GREENHOUSE GAS EMISSIONS THROUGH ENERGY  
EFFICIENCY, RENEWABLE ENERGY PRODUCTION,  
WATER CONSERVATION,  
AND WATERSHED MANAGEMENT**

---

**WHEREAS**, consensus exists among the world's leading climate scientists that climate change caused by emissions of greenhouse gases from human activities is among the most significant problems threatening ecological stability and human well-being today; and

**WHEREAS**, documented impacts of climate change include, but are not limited to, increased occurrences of extreme weather events (e.g. droughts, floods, fires, hurricanes) adversely impacting ecosystems, demographic patterns, human health, wildlife, and economic value chains; and

**WHEREAS**, the 2015 *Santa Fe Basin Study: Adaptations to Projected Changes in Water Supply and Demand* concluded that, as a result of greenhouse gas emissions, the native Rio Grande and Santa Fe River water supplies relied upon by the County's water utility are projected to decrease by approximately 33% by the 2050s, and that a significant reduction in snowpack will occur; and

**WHEREAS**, the Board of County Commissioners of Santa Fe County (Board) has expressed its intent to support greenhouse gas emission reduction within the County and the community in numerous resolutions including most recently Resolution No. 2017-68 in which the County agrees to reduce greenhouse gas emissions per the targets set in the Paris Agreement in order to limit global mean temperature increase to less than 2 degrees Celsius above pre-industrial levels, with an expectation that this goal should be reduced to 1.5 degrees in the future; and

**WHEREAS**, in Resolution No. 2017-24, the Board supported Senate Bill 360 requiring the competitive resource procurement for electric utilities in the State of New Mexico; and

**WHEREAS**, many state and local governments in New Mexico, including Santa Fe County, have already begun reducing their greenhouse gas emissions through implementing energy efficiency, waste reduction, recycling, water conservation, fleet efficiency, and renewable energy production in County facilities and operations; and

**WHEREAS**, the New Mexico Public Regulation Commission (NMPRC) has opened a docket, NMPRC No. 17-00211-UT, to consider a rule that would have electric utilities in New Mexico reduce their carbon footprint by 4 percent per year from 2012 levels, with an 80% reduction required by 2040; and

**WHEREAS**, the Board wishes to encourage and work with the State of New Mexico, other counties in New Mexico, and local governments to continue to prioritize the reduction of greenhouse gas emissions; and

**WHEREAS**, the New Mexico State Legislature, New Mexican counties, and other local governments in New Mexico have significant opportunities to provide incentives and resources to reduce greenhouse gas emissions; and

**WHEREAS**, policies that will increase reliance on renewable energy resources that New Mexico is well qualified to provide have and will continue to create economic opportunities for the citizens and businesses of New Mexico;

**NOW, THEREFORE, BE IT RESOLVED** by the Board as follows:

1. Santa Fe County supports legislation that raises the renewable energy portfolio standards to 50% renewables by 2030 and for 80% by 2040 for all New Mexican electric utilities.
2. Santa Fe County supports a NMPRC rule that establishes a State clean energy standard to reduce the State's electric utilities' carbon footprint by 80% by 2040 below 2012 levels.
3. Santa Fe County supports legislation to provide a state tax credit for residential and business property owners who install renewable energy production systems and/or battery storage systems.
4. Santa Fe County supports pricing greenhouse gas emissions, whether via a carbon fee-and-dividend system, carbon tax, clean energy standard, or other mechanism, at a level designed to limit global warming to 1.5 degrees Celsius in accordance with the Paris Agreement.
5. Santa Fe County supports legislation to enable community solar electric projects in New Mexico.
6. Santa Fe County supports legislation requiring electric utilities to use competitive and transparent resource procurement practices.



7. Santa Fe County supports legislation to reduce waste and increase recycling.
8. Santa Fe County supports extended producer responsibility legislation.
9. Santa Fe County supports legislation and administrative actions that requires the capture of natural gas that might otherwise be vented and flared.
10. Santa Fe County supports legislation and agency actions that protect open space and wildlife and the ecosystem benefits they provide.
11. The Board directs staff to work with New Mexico Association of Counties, the City of Santa Fe, and other local governmental entities to build support for legislative and administrative priorities promoting the matters identified herein.
12. The Board directs staff to participate with partners in tracking and supporting State laws consistent with this Resolution as they are heard, implemented, and enforced by the Public Regulation Commission (PRC).

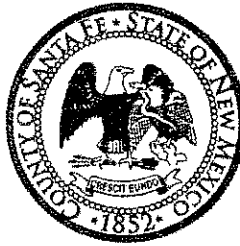

**Subject:** Resolution No. 2018-\_\_\_\_, A Resolution Supporting the New Mexico Rio Grande Trail Master Plan

### **Background and Summary:**

The Rio Grande Trail Commission, which was established in July 2015, was created to plan, design and construct a recreational trail called the Rio Grande Trail (RGT) that runs parallel to the Rio Grande and extends the length of New Mexico from Texas to Colorado. The trail is intended for New Mexico residents and visitors to enjoy the natural beauty of New Mexico and the Rio Grande and learn about the culture and history of our fine state. The commission is made up of eight commissioners with various backgrounds and special interests and four legislative advisory members including two legislative representatives and two New Mexico state senators. They are charged with ensuring that the trail is established in a manner that minimizes environmental impacts and preserves sensitive habitat as well as defining and recommending viable path routes and mitigating challenges related to its establishment.

The Santa Fe County supports trail systems throughout the state of New Mexico and values the outdoor opportunities a coordinated effort can bring to the state and the cities and towns around New Mexico. The attached resolution states the Board of County Commissioners intention to support the efforts of the RGT Commission including opportunities to coordinate efforts related to the RGT to include connection of County trails to the main RGT trail system, and further, to support marketing, economic development and education efforts associated with the RGT.

## **A RESOLUTION TO SUPPORT THE NEW MEXICO RIO GRANDE TRAIL MASTER PLAN**

---

**WHEREAS**, the Santa Fe County supports trail systems throughout the state of New Mexico; and values the outdoor opportunities a coordinated effort can bring to the state of New Mexico and the cities and towns throughout New Mexico; and

**WHEREAS**, the mission of the Rio Grande Trail Commission is to plan, design, and construct a recreation trail called the "Rio Grande Trail" (RGT) that runs parallel to the Rio Grande and extends the length of New Mexico from Texas to Colorado; and

**WHEREAS**, the RGT will traverse a diversity of majestic New Mexico landmarks and natural and cultural landscapes including six state parks, two national wildlife refuges, and three national monuments and will also travel through multiple governmental jurisdictions including at least 10 cities with populations of more than 5,000 and 22 counties, including, of course, Santa Fe County; and

**WHEREAS**, Santa Fe County acknowledges the Tribal lands along the Rio Grande, and supports continued communication and coordination with Tribal governments throughout the RGT planning process; and

**WHEREAS**, the RGT will provide an excellent potential for economic development and recreation for the state of New Mexico and communities and small businesses along the path; and

**WHEREAS**, in 2016 more than 5 million people visited New Mexico state parks and outdoor recreation contributed \$3.8 billion dollars of annual economic impact throughout New Mexico; and

**WHEREAS**, Santa Fe enjoys both various outdoor trail opportunities throughout the City of Santa Fe, Santa Fe County, and Hyde Memorial State Park; and recreational opportunities provided by proximity to the Rio Grande;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Santa Fe County, hereby:

1. Supports the efforts of the RGT Commission to develop the Rio Grande Master Plan that will guide the development of the border to border trail;

2. Seek opportunities to coordinate efforts related to the RGT to include connection of County trails to the main RGT trail system;
3. Participate in the larger marketing and economic development efforts related to the RGT to support both the trail and county business opportunities;
4. Support educational efforts as related to the cultural and natural resource as well as recreational opportunities of the RGT.

**BE IT FURTHER RESOLVED** that the Board of County Commissioners of Santa Fe County supports the development of and connection to the RGT where possible and is authorized to do all deeds necessary in the accomplishment of the partnership with the RGT.
