ISSUE:

The reappointment and new appointment of individuals to the Health Policy and Planning Commission (HPPC).

BACKGROUND:

The resolution establishing membership on the HPPC provides for 13 members, two from each of the five districts, one appointed by the Mayor of the City of Santa Fe, and two Countywide appointments. The resolution allows for members to serve two terms.
