Administration, Facilities, Fleet

- Architectural and engineering work underway for Turquoise Trail Station 3, La Puebla Station 1, Chimayo Station 1, Eldorado Station 1, and the Madrid Station 1. Regular weekly meetings held to facilitate these projects.
- Rescue vehicles for Glorieta, Madrid, and Pojoaque received and placed into service at each respective Fire District.
- Participated with auditors on fixed asset review, and scheduled meetings for volunteer Districts for review of Personal Protective Gear and radio procedures.
- Work underway on completion of the Department's 5 Year Plan. Several volunteer Fire District and Leadership Team focus group sessions conducted throughout the month.
- Annual ladder and hose testing schedule prepared for Districts and Fire Administration. Testing to begin
 in October.
- Continued work and discussions on an updated volunteer incentive plan. The updates will be formalized and moved to the BCC for approval.
- Initiated the renewal process for Fire and Rescue Impact Fees. Working with Planning Division to compete the project by the end of the calendar year.

Operations and Training

Emergency Responses/727 total - 177 Fire Incidents and 550 EMS Incidents

- Advanced EMT class for 9 career firefighters underway. Testing and completion of the program scheduled for October.
- Successfully completed Battalion trainings for three shifts. 8 hours of off-duty training for each firefighter on pump and ladder operations.
- Hiring process underway for the Department's next career cadet academy. Six positions to be filled with anticipated academy start date of October 15th.
- 25 Regional staff completed the Fire Instructor 1 course. All final testing for IFSAC certification completed successfully.
- Extensive work underway to assist RECC and CAD vendor with reconfiguration of CAD mapping in preparation for installation of new software at the dispatch center.
- Regional stations will now be dispatched to all Fire Alarm and Smoke check calls. Previously the
 volunteer District handled these calls for initial response. This change will assist volunteer Districts with
 these call types.

New emergency response protocols for Regional staff completed, reviewed, and distributed to all career and volunteer responders. This process has formalized and standardized across all four regions our response configuration for different call types, including fire, rescue, and EMS.
