A RESOLUTION SUPPORTING A SCENIC BYWAYS APPLICATION FOR THE DESIGN AND DEVELOPMENT OF PEDESTRIAN AND BICYCLE TRAILS ALONG HYDE PARK ROAD

WHEREAS, Santa Fe County Growth Management Plan calls for the establishment of interconnecting trail systems for pedestrians and bicycles throughout the region; and

WHEREAS, Hyde Park Road is an essential link to Hyde State Park and the National Forest, providing numerous trail and recreational opportunities; and

WHEREAS, Hyde Park Road – New Mexico Highway 475 has been designated as the Santa Fe Forest Scenic Byway and is consequently eligible for Scenic and Historic Byways funding; and


WHEREAS, the Hyde Park Corridor Planning Group has been working with the Trust for Public Land, the City of Santa Fe and Santa Fe County to design and develop a trail for pedestrian and bicycle use along the highway right-of-way that will improve the safety of this roadway and enhance its use.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners (BCC) of Santa Fe County that:

The Governing Body supports the Trust for Public Land's application requesting TEA-21 Scenic Byways funds for the design and development of pedestrian and bicycling trail along Hyde Park Road which is to be accomplished as a cooperative effort between the Hyde Park Corridor Planning Group, the Trust for Public Land, the City of Santa Fe, and Santa Fe County.


