### A RESOLUTION AUTHORIZING LEGAL HOLIDAYS AND CLOSING OF COUNTY OFFICES FOR CALENDAR YEAR 2001


**WHEREAS**, the Board of County Commissioners proposes to allow certain legal holidays to be observed as non-working days for employees of Santa Fe County; and

**WHEREAS**, it is incumbent upon all employees to be allowed the opportunity to celebrate these historic events.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Santa Fe County that the following dates shall be observed as legal holidays and non-working days by the employees of Santa Fe County. Firefighters on 207K exemption will observe holidays on the ACTUAL Holiday.


