To budget a sufficient source of revenue for a full year of realized debt service expenditure. During the budget preparation for FY '00, investment income was overstated as a source of revenue for debt service expenditure resulting in an insufficient request to meet budgeted expenditures.

Why was this request not included in the Fiscal Year 2000 Operating Budget?

During the budget preparation process for FY '00, it was anticipated that the public facility bond may be defeased during the upcoming year. Insufficient resources were identified as sources of revenue to accommodate a full fiscal year's debt service expenditure.

3) Is the transfer recurring or non-recurring and what are the future funding impacts of this request?

This transfer is non-recurring. The impact of funding in the future may entail a larger annual transfer from either the bond proceeds fund (370) for a total amount of approximately \$410,000 per year. This represents a full year of debt service.
