WHEREAS, in the course of its regular operations, the Housing Authority comes into possession of criminal records, as well as records of drug treatment or registered sex offender status of both residents and applicants; and

WHEREAS, these records must be maintained securely and kept from improper use; and

WHEREAS, the Housing Authority is dedicated to maintaining the confidentiality of its residents and applicants and will not disclose to any person or entity the contents of such documents except for the official use in the application process or in court proceedings; and

WHEREAS, the Board of County Commissioners has the authority to approve the Resolution adopting the Criminal, Drug Treatment, and Registered Sex Offender Classification Records Management Policy.

NOW THEREFORE BE IT RESOLVED, by the Santa Fe County Board of Commissioners that the Criminal, Drug Treatment, and Registered Sex Offender Classification Records Management Policy, which is included as Exhibit "A" of this resolution is hereby adopted.

CRIMINAL, DRUG TREATMENT, AND REGISTERED SEX OFFENDER CLASSIFICATION RECORDS MANGEMENT POLICY

PURPOSE

In the course of its regular operations, the Santa Fe County Housing Authority comes into possession of criminal records as well as records of drug treatment or registered sex offender status of both residents and applicants. While necessary to accomplish Housing Authority business, these records must be maintained securely and kept from improper use.

ACQUISITION

All adult applicants and residents shall complete the Santa Fe County Housing Authority's Authorization for Release of Police Records when they apply for housing or their name has come up on the waiting list. This check is done for the purpose of screening applicants for housing. All requests for criminal records or records of drug treatment or registered sex offender status will direct the records to be sent to the Housing Specialist requesting the information. Only these individuals shall have access to the records received. He or she shall discuss the records with other Santa Fe County Housing Authority employees only as required to make a housing decision.

MAINTENANCE

The Santa Fe County Housing Authority will keep all criminal records or records of drug treatment or sex offender status that are received confidential. These records will be used only to screen applicants for housing or to pursue evictions. The records will not be disclosed to any person or other entity except for official use in the application process or in court proceedings. No copies will be made of the records except as required for official or court proceedings.

Criminal records or records of drug treatment or registered sex offenders status will be kept in a file separate from other application or eviction information. These files will be maintained in a different cabinet that is locked and kept in a secure location. Only specified employees shall have access this cabinet.

DISPOSITION 1755238

The records shall be destroyed once action is taken on the application for housing and any grievance hearing or court proceeding has been completed and the action is finalized. A notification of destruction will be maintained.
