These funds will be budgeted in the Solid Waste Division's budget for the purchase the items destroyed in the fire. This request will increase the budget in the following line items/Categories; Field Supplies/Supplies - \$1,500, Inventory Exempt/Supplies - \$850, Equipment/Maintenance - \$4,834, and Equipment & Machinery - \$4,000.
- Why was this request not included in the Fiscal Year 2000 Operating Budget? The Public Works Department did not know during the FY 2000 budget preparation period that equipment and supplies would need to be replaced due to an unexpected fire.
- Is the transfer recurring or non-recurring and what are the future funding impacts of this request? The transfer will be non-recurring. However the remaining insurance claim amount (\$7,000.06) will need to be budgeted for the in the Solid Waste Divisions budget in FY 2001 to purchase scale equipment that was also destroyed in the fire. The Solid Waste Department's current scales will not be operable at the new Eldorado Transfer Station unless this amount is re-authorized.
