**A RESOLUTION SUPPORTING A GRANT APPLICATION  
TO NEW MEXICO STATE PARKS DIVISION FOR RECREATIONAL TRAILS  
AND ENSURING A LOCAL FUNDS MATCH.**

---

WHEREAS, the Federal Recreation Trails Program (RTP), or "TEA 21," funds New Mexico State Parks Division's Recreational Trails Funding Program. In FY2000, the New Mexico funding allocation for this program is \$911,437. The program provides an 80 percent federal grant for each project with a 20 percent local match; and

WHEREAS, in 1999 Santa Fe County began to acquire over 1,100 acres of land in the Cerrillos Hills for open space protection and recreation purposes, as recommended by the County Open Land and Trails Planning and Advisory Committee; and

WHEREAS, the County Open Land and Trails Planning and Advisory Committee has recommended that the County leverage local funds whenever possible for the Wildlife, Mountains, Trails and Historic Places Program; and

WHEREAS, the Cerrillos Hills Park Coalition has spent numerous hours planning for improvements and management of the park and has developed an internal trail system for the park; and

WHEREAS, a trail within the park will ultimately become part of a regional trail system; and


WHEREAS, for the proposed \$50,000 project, \$10,000 is necessary for the local match amount in order to be awarded \$40,000 federal match through TEA 21; and

WHEREAS, Santa Fe County, in partnership with National Park Service and Cerrillos Hills Park Coalition, wishes to receive funding to oversee improvements to the main trailhead within the park.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners (BCC) of Santa Fe County that we approve of the Recreational Trails Program application to be submitted to the New Mexico State Parks Division in February 2000, and ensure a local funds match.
