**A RESOLUTION SUPPORTING A GRANT APPLICATION
TO NEW MEXICO STATE PARKS DIVISION FOR RECREATIONAL TRAILS
FUNDING PROGRAM AND AUTHORIZING A LOCAL FUNDS MATCH FOR
LOS CERRILLOS HILLS HISTORIC PARK.**

WHEREAS, the Federal Recreation Trails Program (RTP), or "TEA 21," has allocated \$754,000 to New Mexico State Parks Division's Recreational Trails Funding Program in FY2001. The program provides an 80 percent federal grant for each project with a 20 percent local match; and

WHEREAS, the County Open Land and Trails Planning and Advisory Committee has recommended that the County leverage local funds whenever possible for the Wildlife, Mountains, Trails and Historic Places Program; and

WHEREAS, in 1999 Santa Fe County acquired over 1,100 acres of land in the Cerrillos Hills for open space protection and recreation purposes, as recommended by the County Open Land and Trails Planning and Advisory Committee; and

WHEREAS, the Cerrillos Hills Park Coalition has spent numerous hours planning for improvements and management of the park and has developed a proposed internal trail system for the park; and

WHEREAS, a trail within the park will ultimately become part of a regional trail system; and

WHEREAS, Santa Fe County, in partnership with National Park Service and Los Cerrillos Hills Park Coalition, wishes to receive funding to oversee improvements to the main trailhead, interpretive/informational signs and support of youth crews for maintenance within the park; and

WHEREAS, the cost of said improvements shall be approximately \$55,000; and

WHEREAS, for the proposed \$55,000 project, \$11,000 is necessary for the local match in order to be awarded \$44,000 federal match through TEA 21.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners (BCC) of Santa Fe County that:

The Governing Body supports the TEA-21 Recreational Trails Program application to be submitted to the New Mexico State Parks Division in February 2001, and authorizes a local funds match.




