


**WHEREAS**, this equipment has been deemed obsolete, inoperable, or too costly to repair by Santa Fe County, and

**APPROVED, ADOPTED AND PASSED** this 31<sup>th</sup> day of July 2001.

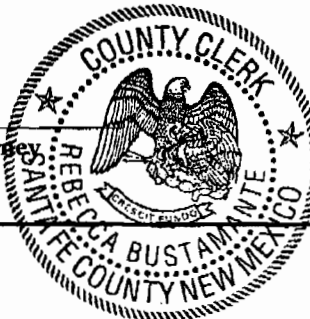
