This request is to transfer funding from FY 2001 Project Developments and Road Maintenance budgets to the FY 2001 Avenida Eldorado Project budget. During construction of the Avenida Eldorado Project in FY 2001 additional funding was needed to complete construction of the project. The Public Works Department expended funds from the Project Development Division budget (General Fund) and the Road Maintenance Division budget (Road Fund) to complete the project in a timely basis. It is therefore necessary to transfer these expenditures/costs to the Avenida Eldorado Project budget in order for them to be Capitalized.

This request is to transfer funding from FY 2001 Project Developments and Road Maintenance budgets to the FY 2001 Tierra Del Oro Project budget. During construction of the Tierra Del Oro Project in FY 2001 additional funding was needed to complete construction of the project.
