 The purchase of seven (7) AVC Voting Machines. Money was set aside last Fiscal Year in the Capital Outlay Package to purchase 7 machines outright. It was the intention of the County Clerk to acquire these machines and the machines for Fiscal Year 2002 at the same time. Purchasing and Lease Purchasing voting machines requires approval by the BCC through resolutions and approval by the State Board of Finance. Through miscommunication between my staff and the Finance Department, the funds allocated in fiscal year 2001 were not encumbered by June 30, 2001. The Clerk's Office is requesting that these funds be given back to her office to purchase these machines.
