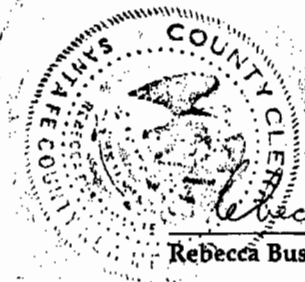
**WHEREAS**, this equipment has been deemed obsolete, inoperable, or too costly to repair by Santa Fe County, AND
