**A RESOLUTION DECLARING A STATE OF EMERGENCY IN
DITCHES WITHIN SANTA FE COUNTY.**

WHEREAS, Santa Fe County has suffered severe rainstorms and ditch flooding since on or about the 12th day of August 2001; and,

WHEREAS, extensive damage has been caused to ditches within Santa Fe County; and

WHEREAS, the damage has resulted in undue human suffering and hardship and threatens the safety, health, welfare, and well-being of citizens and economic function of Santa Fe County; and


WHEREAS, all locally available public and private resources and forces available to mitigate and alleviate the damage are deemed insufficient to cope with the resulting situation, initiate repairs, and meet restoration requirements;

NOW, THEREFORE, the Board of County Commissioners, by virtue of the authority provided by Santa Fe County Resolution 1993-57 and the New Mexico Civil Emergency Preparedness Act (NMSA 1978, 12-10-01 to 12-10-11) does hereby declare the ditches within Santa Fe County to be disaster areas for the purpose of exercising necessary emergency powers and expenditure of available resources, and requesting aid, assistance, and relief programs and funds available from the State of New Mexico.



SANTA FE COUNTY AND THE CITY OF SANTA FE
JOINT CIVIL EMERGENCY PREPAREDNESS RESOLUTION

A RESOLUTION ESTABLISHING A JOINT CIVIL EMERGENCY PREPAREDNESS ORGANIZATION FOR SANTA FE COUNTY AND THE CITY OF SANTA FE WITH A COORDINATOR AND STAFF: DEFINING THE PURPOSE OF THE ORGANIZATION: CONFERRING CERTAIN POWERS AND AUTHORITY UPON THE COORDINATOR: PROVIDING FOR THE FINANCING OF THE ORGANIZATION:

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE (COUNTY) AND THE CITY OF SANTA FE (CITY):

SECTION 1. There is hereby established under the executive branches of the governments of the City and County, in accordance with Chapter 12, Article 10-1 through 10-10, NMSA 1978, as amended (being Laws of 1959, Chapter 190, as amended) a Joint Department of Civil Emergency Preparedness, which shall consist of:

- A. A coordinator of Civil Emergency Preparedness who shall be appointed at the direction of the Board of Commissioners of the County and City Council of the City of Santa Fe and subject to approval by the State Director.
- B. Such additional professional and administrative staff personnel required to effectively carry out the civil emergency preparedness program, when authorized by the County and City.
- C. All other County officers and employees, together with those volunteer forces enrolled to aid them during periods of emergency shall be considered as part of the civil emergency preparedness organization of the City and County.

SECTION 2. The purpose of the civil emergency preparedness organization is to develop and implement the joint county and city civil emergency preparedness program and to coordinate the efforts of all government agencies and employees and non-governmental agencies to prepare for and function in the event of emergencies endangering the lives and property of the citizens of the City and County. It shall be the duty of said organization to coordinate the development of comprehensive emergency management plans for the effective employment of participating resources to protect the lives and health of the citizens of the City and County, and the private and public property therein from the effects of

natural or man-caused emergency events, including acts of war; and to coordinate the implementation of said plans during periods of emergency. Such plans shall be coordinated with those of all the municipalities within Santa Fe County and in consonance with the State Civil preparedness plans.

SECTION 3

- A. The Civil Emergency Preparedness Coordinator shall be the manager of the Department of Civil Preparedness and shall be responsible to the County and the City for the organization, administration, and operation of the civil emergency preparedness department, staff and joint program of the City and County. The Coordinator, acting for the County and the City, shall coordinate the civil emergency preparedness activities of all County, City, State and Federal agencies, departments and agencies and non-governmental agencies, and shall maintain liaison with and cooperate with the civil emergency preparedness agencies of the federal government, the State of New Mexico and other political subdivisions therein.
- B. The Coordinator shall have the necessary authority to act for the governments of the City and County in all matters pertaining to civil emergency preparedness including the obligation of such County and City funds as may be appropriated and state and federal funds made available for civil emergency preparedness purposes. He shall develop an organizational structure for the department, subject to the approval of the County and the City and is authorized to make appointments to fill the positions established therein.

SECTION 4.

- A. Funds for necessary expenses and functions of the Department of Civil Emergency Preparedness, including salaries for approved paid positions, shall be made available through appropriations by the County and the City in accordance with 12-10-7 NMSA, as amended, (being laws of 1959, Chapter 190, as amended).
- B. The Coordinator shall prepare and submit to the County and the City an annual proposed budget for civil emergency preparedness expenditures and functions and shall indicate therein those accounts eligible for matching funds under the federal civil emergency preparedness assistance programs.
- C. Civil emergency preparedness funds may be obligated by the coordinator only in the amounts appropriated and for the purposes authorized by the County and the City.


SECTION 5. For the preservation of the public peace, health


