1	For each Board, Committee, Authority or other body on which one or more, but not al		
2	of the members Board of County Commissioners serves, including the Extraterritoria		
3	Zoning Authority, Regional Planning Authority and Santa Fe Solid Waste Managemer		
4	Agency Board of Directors, one or more alternate members may be appointed and serv		
5	in the following manner:		
6	1.	Alternate members shall be appointed in the same manner as regular	
7		members.	
8	2.	If more than one alternate member is appointed to any one body, each	
9		alternate member shall be assigned a priority and shall serve in order of	
10		priority.	
11	3.	Alternate members shall be notified prior to a meeting if a regular member or	
12		other alternate member cannot attend. When replacing a member, an alternate	
13		member shall have the same duties, privileges and powers as regular	
14		members.	
15	4.	An alternate member may vote only in the absence of an appointed member or	
16		other alternate member for whom he or she is the alternate.
