٠ D Please summarize the request and its purpose.

This request decreases the Road Projects Fund (311) for the FY 2002 budget cycle. This resolution will decrease budgets for the CR 84-G, CR 16, CR 8, CR 55-A, CR 58-A, CR 70-A and the La Puebla Pit Tank projects for FY 2002. FY 2002 budgets will be closed out for the CR 42 Arroyo Crossing, CR 74, CR 86, CR 67-F, Richards Avenue, CR 88 and Reata road improvements projects because of non-funding. Almost all of these decreases or close outs, with the exception of CR 58-A,CR 84-G and CR 70-A whose estimated balances were rolled over into FY 2002, are due to requests for funding being denied at the 2001 legislative session. The County will look at requesting funds for these and other road projects during the 2002 Legislative Session.

The Public Works Department has received the 2001 Co-Op Agreements, for the County Road 73 Road Improvements Project, from the New Mexico State Highway and Transportation Department. The Co-Op Agreements are less than the estimated amount budgeted. This resolution will decrease the amount in the CR 73 budget to the appropriate amounts.

- 2) Why was this request not included in the Fiscal Year 2002 Operating Budget? The Public Works Department budgeted these projects based on estimates during preparation of the FY 2002 Operating Budget.
- 3) Is the transfer recurring or non-recurring and what are the future funding impacts of this request? This decrease is not anticipated to be recurring.


